Your Committee on Finance, to which was referred H.B. No. 778, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO INTEGRATED LAND USE,"

The purpose of this measure is to require the Office of Planning and Sustainable Development to conduct an integrated land use study that incorporates the State's various climate and sustainability goals and studies to serve as a guide for planning and decision-making on the use of agricultural lands.

Your Committee received testimony in support of this measure from the Office of Planning and Sustainable Development; Hawai'i Farm Bureau; and Hawai'i Farmers Union.

Your Committee has amended this measure by:

- (1) Changing the appropriations to unspecified amounts; and
