"A BILL FOR AN ACT RELATING TO THE ARTS,"

H.B. No. 925 was introduced as a short-form bill, which is sometimes referred to as a "vehicle" bill primarily used to introduce a bill containing only a general idea as to the purpose of the bill without specific details in the long form.
