The purpose of this measure is to:

- (1) Expand existing crisis intervention programs by implementing a homeless triage and treatment center program for homeless individuals and individuals at risk of being homeless, and who have substance abuse issues or mental illness, within the Alcohol and Drug Abuse Division in the Department of Health; and
- (2) Appropriate funds to the Department of Health to implement the program.

Your Committee received testimony in support of this measure from the Office of the Public Defender; State Health Planning and Development Agency; State Council on Mental Health; Hawai'i Health & Harm Reduction Center; and four individuals.
