The purpose of this measure is to:

- Lower and fix the State's Agricultural Loan Program's interest rates, increase loan limits, and reduce the required number of credit denials;
- (2) Establish a program for a secured line of credit and create a new loan initiative for farm expansion to grow import replacement crops or crops for farm-to-state programs; and
- (3) Appropriate funds.
