Authority and Department of Transportation that offers free, year-round Hawaiian entertainment and visitor education at airports across the State, fostering a Hawaiian sense of place. The program also supports young artists in the State by showcasing student artwork at Daniel K. Inouye International Airport. Your Committees conclude that by urging the expansion of the Kahea Airport Greetings Program to showcase Keiki art in all neighbor island airports, this measure will further enhance the visitor experience and gain deeper appreciation for the unique identities of each island while preserving and perpetuating Native Hawaiian culture.
