Your Committees on Energy and Intergovernmental Affairs and Public Safety and Military Affairs, to which was referred H.C.R. No. 180, H.D. 1, entitled:

Your Committees find that homelessness remains a critical issue in the State, posing concerns to human and environmental health and safety. This measure aims to address this critical

issue by requesting vital stakeholders to take certain action to address the multifaceted issue of homelessness, including supporting the State's Kauhale Initiative to expand emergency and transitional homeless shelters, bridge programs, and permanent supportive housing to meet the diverse needs of the population experiencing homelessness in the State.
