Your Committee on Finance, to which was referred H.C.R. No. 77, H.D. 1, entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE AGRIBUSINESS DEVELOPMENT CORPORATION TO DESIGNATE KUNIA, LEILEHUA PLATEAU, AND POAMOHU AS THE CENTRAL OAHU AGRICULTURAL CORRIDOR AND TO ESTABLISH A LIST PRIORITIZING POTENTIAL AGRICULTURAL INFRASTRUCTURE IMPROVEMENT PROJECTS THAT WOULD PROVIDE THE MOST VALUE TO THE STATE,"
