Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 292, S.D. 1, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO SEXUAL EXPLOITATION,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to establish safe harbor protections for survivors of sexual exploitation who seek medical or law enforcement assistance.

Your Committee on Conference finds that often, victims of sexual exploitation may be afraid to seek assistance or cooperate with law enforcement due to the trauma they have experienced or the fear of being prosecuted for offenses they may have committed. measure establishes safe harbor protections for survivors to allow victims of sexual trauma to access professional help without the fear of facing prosecution from law enforcement.
