"A BILL FOR AN ACT RELATING TO THE FOOD HUB PILOT PROGRAM,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to appropriate funds for the continued implementation of the Food Hub Pilot Program, including the awarding of grants to qualifying food hubs.

Your Committee on Conference finds that food hubs can play an important role in the State's efforts to improve food security and self-sufficiency. This measure supports efforts to encourage the production of more locally grown food, strengthen local supply chains, promote environmental stability, and grow the agricultural economy by providing additional financial assistance to the temporary Food Hub Pilot Program established pursuant to Act 313, Session Laws of Hawaii 2022.
