Your Committee on Economic Development and Tourism, to which was referred S.B. No. 891 entitled:

"A BILL FOR AN ACT RELATING TO ECONOMIC DEVELOPMENT,"

begs leave to report as follows:

The purpose and intent of this measure is to amend the law relating to economic development.

Prior to the hearing on this measure, your Committee posted and made available for public review a proposed S.D. 1, which amends this measure by deleting its contents and replacing it with a measure that:

- (1) Establishes a Gaming Working Group within the Department of Businesses, Economic Development, and Tourism; and
- (2) Requires the Gaming Working Group to submit a report to the Legislature.


Your Committee has amended this measure by adopting the proposed S.D. 1.
