S.C.R. No. 193, S.D. 1, entitled:

BACHELOR'S DEGREE PROGRAMS AND OTHER INNOVATIVE WORKFORCE
DEVELOPMENT PATHWAYS THAT DIRECTLY ALIGN WITH JOB

The purpose of this measure is to request the University of
Hawaii Community Colleges to develop a comprehensive list of
bachelor's degree programs and other innovative workforce
development pathways that directly align with job opportunities
and industry needs within their respective region of service.

Your Committee received testimony in support of this measure
from one individual. Your Committee received comments on this
measure from the University of Hawai'i System.

Your Committee finds that Hawaii's economic vitality depends
on a skilled workforce that meets the needs of key regional
industries. Your Committee further finds that each of the
University of Hawaii Community Colleges play a vital role in
