Your Committee on Finance, to which was referred S.C.R. No. 4  
entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A  
TWENTY-FIVE-YEAR TERM, NON-EXCLUSIVE EASEMENT COVERING A  
PORTION OF STATE SUBMERGED LANDS AT KIKIAOLA, KEKAHA, KAUAI,  
FOR A SHORELINE PROTECTION STRUCTURE, AND FOR USE, REPAIR,  
AND MAINTENANCE OF THE IMPROVEMENTS CONSTRUCTED THEREON,"

twenty-five-year term, non-exclusive easement covering a portion
