SB 140

Status &

RELATING TO INVASIVE SPECIES.
Prohibits the importation of firewood into the State, except for firewood that meets certain standards. Requires firewood that is imported into the State from another state to be certified and labeled as heat-treated. Establishes certain exemptions.

RELATING TO INVASIVE SPECIES PREVENTION.
Authorizes the Department of Agriculture to enforce quarantines issued by the United States Department of Agriculture or another state.

Requires the Department of Agriculture to establish and administer a Biosecurity Fencing Cost-Sharing Program. Appropriates funds.
