HB 756, HD1 (HSCR159) Status

#### RELATING TO HEALTH.

Prohibits the sale of flavored nicotine products and nicotine product flavor enhancers and the mislabeling of e-liquids as nicotine free. Establishes penalties for violations. Authorizes the Department of Health to appoint, commission, or contract for services of inspectors. Establishes positions. Appropriates funds. Effective 7/1/3000. (HD1)
