HB 97, HD1 (HSCR14) Status RELATING TO TRAVEL INSURANCE.

TOU, CPC, FIN

Establishes a new regulatory framework for the sale of travel insurance in the State, including licensing and registration requirements for limited lines travel insurance producers. Effective 10/1/3000. (HD1)

<u>HB 226, HD1</u> (<u>HSCR111</u>) Status RELATING TO WINDSHIELD TINTING.

TRN, CPC, JHA

Prohibits a person from installing, mounting, adhering, affixing, or using any sun screening device in conjunction with the glazing material of a motor vehicle with mirrored, metallic, red, yellow, amber, or blue tint. Requires all drivers and passengers of motor vehicles with applied tint to roll down their windows when stopped by a law enforcement officer at a traffic stop. Lowers the minimum light transmittance levels for sun screening devices on certain motor vehicles. Exempts side windows to the rear of the driver and rear windows on sedans from sun screening device requirements. Increase the minimum and maximum fines for violating sun screening device requirements. Effective 7/1/3000. (HD1)



HB 1179, HD1 (HSCR69) Status

RELATING TO RURAL EMERGENCY HOSPITALS.

HLT, CPC, FIN

Creates a framework for the licensure of rural emergency hospitals by the Department of Health. Provides for the continuation of Medicaid policy protections for hospitals transitioning to a rural emergency hospital designation. Effective 7/1/3000. (HD1)

HB 420, HD1 (HSCR220) **Status**

RELATING TO REMEDIES.

HSG, CPC, JHA

Clarifies the applicability of the statute of repose for actions arising from construction defects. Clarifies the required contents of a notice of claim of construction defect served on a contractor. Amends the process and time frame for a claimant to accept a contractor's offer to settle or inspect and authorize the contractor to proceed with repairs. Limits the amount a claimant can recover if the claimant rejects a contractor's reasonable proposal for inspection or a reasonable offer to remedy. Clarifies the consequences of rejecting an offer of settlement.

Effective 7/1/3000. (HD1)

HB 1291, HD1 (HSCR190) **Status**

RELATING TO AGRICULTURE.

AGR, CPC, JHA

Extends the offense of false labeling of Hawaii-grown coffee to include roasted coffee. Imposes a mandatory \$10,000 fine for each separate offense of false-labeling of Hawaii-grown roasted coffee.

Effective 7/1/3000. (HD1)

HB 755, HD1 (HSCR235) Status

RELATING TO PAID FAMILY LEAVE.

LAB, CPC, FIN

By 1/1/2028, requires the Department of Labor and Industrial Relations to establish a family and medical leave insurance program and begin collecting payroll contributions to finance payment of benefits. By 1/1/2029, requires the Department to start receiving claims and paying benefits under the program. Specifies eligibility requirements and employee protections under the program. Effective

7/1/3000. (HD1)

DECISION MAKING

The following measure(s) were previously heard on **January 30th**, 2025. No public testimony will be accepted.

HB 490 Status

RELATING TO INSURANCE.

CPC, FIN

Requires the Insurance Commissioner to develop comprehensive standards and requirements for condominium associations and developers to obtain property insurance through self-insurance and mutual insurance, and examine and evaluate the feasibility of implementing guaranteed buyback programs and investment-based protection funds.
