SB 1438, SD1 (HSCR1417) Status	RELATING TO HOME CARE AGENCIES. Prohibits home care agencies from providing services outside the scope of their facility license. Effective 7/1/2050. (SD1)	HLT, CPC

SB 1449, SD1, HD1 (HSCR1311) Status	RELATING TO PRIOR AUTHORIZATION OF HEALTH CARE SERVICES. Requires utilization review entities to submit data relating to the prior authorization of health care services to the State Health Planning and Development Agency. Establishes the Health Care Appropriateness and Necessity Working Group within the State Health Planning and Development Agency. Effective 7/1/3000. (HD1)	HLT, CPC
SB 1291, SD1 (SSCR797) Status	RELATING TO CERTIFIED PUBLIC ACCOUNTANTS. Clarifies the education and professional experience requirements for certified public accountant license applicants to establish alternative pathways to licensure. (SD1)	CPC
SB 752, SD1 (SSCR799) Status	RELATING TO INSURANCE. Beginning 1/1/2026, increases the notice period for an insurer to notify a policy holder of a cancellation or nonrenewal of a property casualty insurance policy. Effective 7/1/2050. (SD1)	CPC
SB 1369, SD1 (SSCR795) Status	RELATING TO TITLE 24, HAWAII REVISED STATUTES. Beginning 10/1/2025, amends net solvency report filing requirements for mutual benefit societies, dental insurers, and health maintenance organizations. Effective 7/1/2050. (SD1)	CPC
SB 385, SD1 (SSCR798) Status	RELATING TO CONDOMINIUMS. Requires condominium associations to provide copies of their governing documents, as amended, to owners or their authorized agents, upon request, in print or electronic form, at no additional cost. (SD1)	CPC
SB 140, SD2, HD1 (HSCR1365) Status	RELATING TO INVASIVE SPECIES. Prohibits the importation of firewood into the State from another state and the intrastate transportation or sale of firewood not harvested within the State unless the firewood is heat-treated or the importation, transportation, or sale is authorized by the Department of Agriculture. Effective 7/1/3000. (HD1)	AGR, CPC
