RELATING TO COLLABORATION WITH THE FEDERAL
GOVERNMENT.

ECD, JHA

Allows state and county law enforcement agencies to collaborate with
the federal government for immigration purposes in only limited,
specific circumstances.

RELATING TO IMMIGRATION DETENTION FACILITIES.

ECD, WAL, JHA

Prohibits the Department of Land and Natural Resources and Board of
Land and Natural Resources from disposing of or approving the use or
setting aside of public lands for the establishment of any immigration
detention facility. Prohibits state and county agencies from contracting
with the federal government or processing any permit for this purpose.

RELATING TO DUE PROCESS PROTECTIONS.

ECD, JHA, FIN

Establishes the Due Process in Immigration Proceedings Program
within the Judiciary to provide legal representation to individuals in
immigration-related proceedings in immigration court. Appropriates
funds.

RELATING TO CIVIL RIGHTS PROTECTIONS.

ECD, JHA

Requires state and local law enforcement agencies to notify an individual of their rights when in law enforcement agency custody before any interview with United States Immigration and Customs Enforcement on certain matters regarding immigration violations.

RELATING TO CAPITAL GAINS TAX.

ECD, FIN

Increases the capital gains tax threshold to nine percent. Increases the alternative capital gains tax for corporations to five percent.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least **24 hours** prior to the hearing. Testimony received after this time will be stamped late and left to the discretion of the chair to consider. While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may not be processed.

Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony.

The chair may institute a per-testifier time limit.

Committees meeting in the morning must adjourn prior to the day's Floor Session. Therefore, due to time constraints, not all testifiers may be provided an opportunity to offer verbal comments. However, written submissions will be considered by the committee.

Please refrain from profanity or uncivil behavior. Violations may result in ejection from the hearing without the ability to rejoin.

For remote testifiers, the House will not be responsible for bad connections on the testifier's end.
