SB 1343, SD1 (SSCR1065) Status	RELATING TO THE SMALL BUSINESS REGULATORY REVIEW BOARD. Amends the quorum requirements to do business and validate acts of the Small Business Regulatory Review Board. Effective 7/1/2050. (SD1)	ECD, JHA
SB 1578, SD2 (SSCR841) Status	RELATING TO INTERNATIONAL AFFAIRS. Establishes the Hawaii Sister-State and International Partnerships Commission. Requires the Office of International Affairs to provide support to the Hawaii Sister-State and International Partnerships Commission. Allows the Department of Business, Economic Development, and Tourism to establish out-of-state offices and facilities to support sister-state and other partnerships that promote and enrich the people, cultures, environments, and economies of the State and its international partners, generate revenue for the State, and buy property. Appropriates funds. Effective 7/1/2050. (SD2)	ECD, FIN

RELATING TO THE STATE OF HAWAII FILM COMMISSION.
Establishes the State of Hawaii Film Commission within the Department of Business, Economic Development, and Tourism to support the State's film industries. Establishes the State of Hawaii Film Commission Board within the State of Hawaii Film Commission. Requires investment revenues and returns from made and fees and charges collected by the State of Hawaii Film Commission to be deposited into the Film Industry Development Special Fund. Makes conforming amendments to the Hawaii Film and Creative Industries Development Special Fund. Allows the Department to use the film fund to provide the support and development of facilities, film tax incentives, and other initiatives to grow the State's film industries. Requires annual reports to the Legislature. Appropriates funds. Effective 7/1/2050. (SD2)

RELATING TO PRIVACY.
Adds definitions of "identifier" and "specified data element" and amends the definition of "personal information" for the purposes of notifying affected persons of data and security breaches under existing state law that governs the security breach of personal information. Includes licensees subject to the Insurance Data Security Law among the businesses deemed compliant with security breach notice requirements under existing state law. Effective 7/1/2050. (SD1)

RELATING TO TAXATION.
Exempts the sale of groceries and nonprescription drugs from the general excise tax. Effective 12/31/2050. (SD2)

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least **24 hours** prior to the hearing. Testimony received after this time will be stamped late and left to the discretion of the chair to consider. The chair may institute a per-testifier time limit.

Committees meeting in the morning must adjourn prior to the day's Floor Session. Therefore, due to time constraints, not all testifiers may be provided an opportunity to offer verbal comments. However, written submissions will be considered by the committee.

Please refrain from profanity or uncivil behavior. Violations may result in ejection from the hearing without the ability to rejoin.

For remote testifiers, the House will not be responsible for bad connections on the testifier's end.
