SB 1061 Status & Testimony	RELATING TO DIGITAL EQUITY. Establishes and appropriates funds for a digital navigator pilot program to offer technical assistance with computers and electronic devices to residents.	EDT, WAM
SB 1657 Status & Testimony	RELATING TO THE AGRIBUSINESS DEVELOPMENT CORPORATION. Authorizes the Agribusiness Development Corporation to acquire by condemnation any real property or interest in real property, including real property already devoted to public use, for the purposes of Chapter 163D, HRS. Requires the Agribusiness Development Corporation to make a determination that the property is necessary for the corporation's immediate or future use. Prohibits real property acquired by condemnation from being subsequently transferred or taken for any other public use without the consent of the Agribusiness Development Corporation.	EDT, JDC
SB 1539 Status & Testimony	RELATING TO THE AGRIBUSINESS DEVELOPMENT CORPORATION. Appropriates funds to offset the debt for the Waiahole Water System.	EDT, WAM
SB 891, SD1 (SSCR115) Status & Testimony	RELATING TO ECONOMIC DEVELOPMENT. Establishes a Gaming Working Group within the Department of Business, Economic Development, and Tourism. Requires a report to the Legislature. (SD1)	EDT
