SB 529 Status & Testimony	RELATING TO EDUCATION. Appropriates funds to the Department of Education for its Hoakea Program.	EDU, WAM
SB 1390 Status & Testimony	RELATING TO COMPUTER SCIENCE LEGISLATIVE REPORT. Changes the due date of the Department of Education's computer science legislative report from June 30 to twenty days prior to the start of the legislative regular session.	EDU
SB 1388 Status & Testimony	RELATING TO EDUCATION. Adds two voting members that represent the Department of Education or the Board of Education to the School Facilities Authority Board.	EDU, WAM
SB 527 Status & Testimony	RELATING TO EDUCATION. Establishes, and appropriates funds for, five full-time equivalent (5.0 FTE) positions within the Civil Rights Compliance Branch of the Department of Education.	EDU, WAM
SB 868 Status & Testimony	RELATING TO THE SCHOOL BUS DRIVER CERTIFICATION SUBSIDY PILOT PROGRAM. Establishes a one-year School Bus Driver Certification Subsidy Pilot Program within the Department of Education for the 2025-2026 school year. Requires reports to the Legislature. Appropriates fund.	EDU, WAM

Requires the School Facilities Authority to consult with the Department of Education and other impacted departments or agencies prior to the conveyance of ownership rights or lease of lands to the School Facilities Authority.
