SB 585 Status & Testimony	RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS TO ASSIST BANA PACIFIC INC. Authorizes the issuance of special purpose revenue bonds to assist Bana Pacific Inc. in constructing a biogas production facility.	EIG, WAM
SB 964 Status & Testimony	RELATING TO WASTE-TO-ENERGY. Requires the Hawaii State Energy Office to establish a public-private partnership to develop a waste-to-energy generating facility in each county having a population below 800,000.	EIG, WAM
SB 996 Status & Testimony	RELATING TO RENEWABLE ENERGY. Clarifies that adjustments linked to premium interest rates for high yield credit are just and reasonable. Authorizes the Public Utilities Commission to include these incremental adjustments to the rate for electricity generated from nonfossil fuels.	EIG, CPN
SB 1068 Status & Testimony	RELATING TO RENEWABLE ENERGY. Requires the Hawaii State Energy Office to conduct a statewide environmental assessment for, and subsequently administer, a Slim-Hole Resource Characterization Program. Requires reports to the Legislature. Appropriates funds.	EIG, WAM

Authorizes the Clean Energy and Energy Efficiency Revolving Loan Fund to be used to provide financial assistance to underserved ratepayers, in addition to other eligible borrowers. Appropriates funds into and out of the Clean Energy and Energy Efficiency Revolving Loan Fund.

Decision Making to follow, if time permits.
