RELATING TO TRANSPORTATION DEMAND MANAGEMENT. GVO/TCA, WAM
Establishes a transportation demand management program to reduce vehicle emissions and miles traveled by single-occupancy vehicles. Establishes 2 permanent full-time equivalent (2.0 FTE) co-administrator positions, 1 in the department accounting and general services and 1 in the Department of Human Resources Development. Subsidizes public transit and bikeshare passes for state employees. Authorizes incentives for parking opt-out. Appropriates moneys.

RELATING TO PARKING DEMAND MANAGEMENT. GVO/TCA, WAM
Establishes a parking demand management program. Requires the Department of Accounting and General Services to transition all state employee monthly parking options to daily rate parking. Requires the Department to procure parking reservation software. Creates 2 permanent full-time equivalent (2.0 FTE) positions. Appropriates moneys.

Beginning 1/1/2027, establishes a preference in the Hawaii Public Procurement Code that favors bids or offers from businesses that intend to use a higher proportion of all-electric construction vehicles in Department of Transportation construction projects.

Decision Making to follow, if time permits.
