Appropriates funds to the University of Hawaii for the development of an action plan and pre-engineering concept plan to help with debris management and water quality control in the Ala Wai watershed. Effective 7/31/2050. (SD1)	HED, WAL, FIN
<u>SB 1232, SD2</u> (<u>SSCR771)</u> <u>Status</u>	RELATING TO WASTEWATER SYSTEMS. Establishes a 3-year New Wastewater Technology Testing Pilot Program within the University of Hawaii Water Resources Research Center to test and evaluate new wastewater technology systems in coordination with University of Hawaii Sea Grant College Program, University of Hawaii College of Engineering, Department of Health, Department of Hawaiian Home Lands, and appropriate county agencies. <u>SB 865, SD1</u> (<u>SSCR781)</u> <u>Status</u>	RELATING TO AGRICULTURE. Appropriates funds to establish a permanent Educational Support Associate position within the University of Hawaii College of Tropical Agriculture and Human Resilience's Kona Cooperative Extension. Effective 7/31/2050. (SD1)	HED, FIN
<u>SB 1487, SD1</u> (<u>SSCR864)</u> <u>Status</u>	RELATING TO THE UNIVERSITY OF HAWAII REVENUE BONDS.
