HB 244 Status	RELATING TO THE DEPARTMENT OF HUMAN SERVICES. Appropriates funds for the department of human services to collaborate with community-based organizations to address the need for social services in the State.	HSH, FIN
HB 1349 Status	RELATING TO MEDICAID. Appropriates funds to the Department of Human Services to authorize Medicaid coverage through the Children's Health Insurance Program to income-qualified pregnant persons and children regardless of immigration status.	HSH, FIN
HB 613 Status	RELATING TO HOMELESS YOUTH. Appropriates funds to the Department of Human Services to provide	HSH, FIN

HB 1101 Status	RELATING TO SAFE SPACES FOR YOUTH PROGRAM. Makes the Safe Spaces for Youth Pilot Program permanent within the Office of Youth Services. Requires the program to collaborate with all state and county departments that offer services for youth and young adults to coordinate the identification of youth and young adults who are experiencing homelessness and placement of these youth at a shelter for homeless youth or young adults. Authorizes the Office of Youth Services to contract with nonprofit organizations to provide shelters for homeless youth or young adults. Requires the Office of Youth Services to submit a report twenty days prior to the regular session of the Legislature.	HSH, FIN
HB 705 Status	RELATING TO THE EXECUTIVE OFFICE ON AGING. Establishes a temporary Medi-Medi Project within the Hawaii State Health Insurance Assistance Program administered by the Executive Office on Aging to assist older adults, Medicare beneficiaries, individuals with disabilities, and other underserved populations who may qualify for various low-income subsidy programs to gain access to their benefits. Requires the Executive Office on Aging to submit reports to the Legislature. Appropriates funds.	HSH, FIN
HB 327 Status	RELATING TO STATE CHILDCARE. Appropriates funds to the office of the governor for a state childcare facility for state employees and their families.	HSH, FIN
HB 324 Status	RELATING TO BABY BONDS. Establishes the Baby Bonds Working Group to develop a plan for the creation of a baby bonds program for the State to address intergenerational poverty and wealth inequality in Hawaii.	HSH, FIN
HB 943 Status	RELATING TO HOMELESSNESS. Requires and appropriates funds for the Department of Health to establish a homeless triage and treatment center program to serve homeless individuals and individuals at risk of homelessness with substance abuse issues or mental illness.	HSH, FIN
HB 212 Status	RELATING TO HOMELESSNESS. Requires the Statewide Office on Homelessness and Housing Solutions to establish a permanent Return-to-Home program to return homeless individuals in the State to families and relatives in their home states. Requires the Office to report to the Legislature. Appropriates funds.	HSH, FIN
HB 1420 Status	RELATING TO SUPPORTIVE HOUSING. Clarifies the funding mechanism for the supportive housing pilot program. Extends the sunset date for the supportive housing pilot program to 6/30/2030.	HSH, FIN
