HB 806, HD1 (HSCR130) Status	RELATING TO FIREWORKS. Appropriates funds for the Department of Law Enforcement to conduct sting operations on Oahu to enforce fireworks ordinances or laws. Effective 7/1/3000. (HD1)	LAB, JHA, FIN
HB 438, HD1 (HSCR122) Status	RELATING TO DUE PROCESS PROTECTIONS. Establishes the Due Process in Immigration Proceedings Program within the Judiciary to provide legal representation to individuals in immigration-related proceedings in immigration court. Appropriates funds. (HD1)	ECD, JHA, FIN
HB 386 Status	RELATING TO DANGEROUS DRUGS. Conforms fentanyl to the possession offense thresholds for methamphetamine, heroin, morphine, and cocaine.	ЈНА
HB 388 Status	RELATING TO TORTURE. Defines and prohibits the offense of torture.	JHA

HB 393 Status	MAKING AN APPROPRIATION FOR CAREER CRIMINAL PROSECUTION. Appropriates moneys to the Department of the Prosecuting Attorney of the City and County of Honolulu for the career criminal prosecution unit.	JHA, FIN
HB 394 Status	MAKING AN APPROPRIATION FOR THE VICTIM WITNESS ASSISTANCE PROGRAM. Appropriates moneys as a grant-in-aid to the City and County of Honolulu Department of the Prosecuting Attorney for the Victim Witness Assistance Program.	JHA, FIN
HB 538 Status	RELATING TO SAFE ENTRYWAYS. Prohibit individuals from residing in a doorway or surrounding area of certain places. Gives county police departments primary authority to enforce the prohibition.	JHA
HB 103 Status	RELATING TO SENTENCING. Changes the age for which individuals are eligible for life without parole sentences from eighteen years of age or older to twenty-one years of age or older.	JHA
HB 610 Status	RELATING TO COLD CASE INVESTIGATIONS. Establishes and appropriates money for a Cold Case Investigation Unit within the Department of the Attorney General. Prioritizes unsolved cases involving an Indigenous victim.	JHA, FIN
HB 147 Status	RELATING TO ATTACHMENT AND EXECUTION OF REAL PROPERTY. Increases the real property exemption amount for attachment or execution.	JHA, FIN
HB 127 Status	RELATING TO PRETRIAL RELEASE. Requires the court to enter on the record its written findings regarding the necessity of the conditions imposed on a defendant's release. Requires bail to be set in an amount that the defendant can afford based on certain factors.	ЈНА
HB 128 Status	RELATING TO CRIMINAL JUSTICE REFORM. Establishes factors under which officers may, without warrant, arrest and detain persons for petty misdemeanors and violations. Requires officers to record the factors that justified the warrantless arrest.	ЈНА
HB 560 Status	RELATING TO THE JUDICIARY. Appropriates funds to the judiciary for services contracted with community-based organizations that deliver essential services, streamline judicial processes, and support the judiciary's capacity to effectively meet the needs of vulnerable households. HB 1247 Status	RELATING TO CRIMINAL PROCEEDINGS. Provides immediate judicial review of orders fixing minimum terms of imprisonment.	JHA, FIN

RELATING TO GEOGRAPHICAL RESTRICTIONS.

Establishes limitations on geographical restrictions provided as a condition of probation.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least <u>24 hours</u> prior to the hearing. Testimony received after this time will be stamped late and left to the discretion of the chair to consider. The chair may institute a per-testifier time limit.
