RELATING TO THE HAWAII NATIONAL GUARD. **SB 1381** PSM, WAM Allows the commander of the Hawaii Air National Guard to hold Status & the rank authorized by the Department of the Air Force. Testimony Provides the Adjutant General with the flexibility to assign either the Chief of Staff or the Assistant Adjutant General to lead the Hawaii Air National Guard. Authorizes the pay and allowances for the Chief of Staff of the Hawaii Air National Guard to be determined according to the pay tables of the Regular Air Force of the United States. Effective 7/1/2025. RELATING TO THE NATIONAL GUARD. PSM, JDC **SB 1382** Specifies that intentionally or knowingly causing bodily injury Status & to a national guard member in the performance of duty is a class Testimony C felonv. PSM, WAM

Status & RELATING TO EMERGENCY PREPAREDNESS.

Establishes the Community Readiness Centers Program to be

implemented and administered by the Hawaii Emergency
Management Agency. Establishes the Community Readiness
Centers Special Fund to fund the Community Readiness
Centers Program. Renames the Environmental Response,
Energy, and Food Security Tax to the Environmental Response,
Energy, Food Security, and Resilience Tax and directs a portion
of the tax into the Community Readiness Centers Special Fund.
