Status & Testimony	RELATING TO BUILDING CODES. Beginning 1/1/2028, makes the most recent Hawaii state building codes adopted by the state building code council supersede all existing county building codes and thereafter allows counties to remove requirements of the state building codes or add requirements to the state building codes only with prior council approval. Repeals the counties' authority to adopt, amend, and update the Hawaii state building codes for their respective county building codes.	PSM, JDC
SB 626 Status & Testimony	RELATING TO DISASTER PREPAREDNESS. Prohibits the planting of large trees along evacuation routes. Requires the Hawaii Emergency Management Agency to identify large trees along evacuation routes and trim, spray, or remove large trees having the potential to obstruct an evacuation route. Defines evacuation route. Appropriates moneys.	PSM, WAM
SB 692 Status & Testimony	RELATING TO SPRAY PAINT. Regulates the retail and wholesale sales of spray paint. Designates the Department of Law Enforcement with jurisdiction.	PSM, CPN/JDC
