To assist the Hawaii State Senate with its confirmation process, we request that you submit the following information to our office no later than February 21st, 2025, to ensure that we proceed in a timely manner:

1. Why do you wish to be a member of the Emergency Medical Services Advisory Committee.

I am a fellowship trained emergency medicine physician with subspecialty board certification in Emergency Medical Services. I have always had a strong sense of duty to my community and would like to bring my developed skill set to help prevent and solve issues affecting the people of Hawaii.

2. What do you perceive are the roles and responsibilities of a member of the Emergency Medical Services Advisory Committee.

Providing insight from their professional and/or personal experience to the impact of current challenges and its effects on the community. When certain issues are discovered or anticipated, providing salient and feasible recommendations to mitigate or eliminate the negative impacts than could occur.

3. Given your understanding of the roles and responsibilities as a member of the Emergency Medical Services Advisory Committee, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, and knowledge that would aid you as a member of the board.

I completed training as an EMT-B and passed the exam from National Registry of Emergency Medicine Technicians (NREMT) and previous held a license in the state of Georgia as and EMT-B. I then was admitted and graduated from Medical School before residency training in Emergency Medicine followed by fellowship training in EMS. Building on skills first developed as an Eagle Scout, I also participated in additional Wilderness medicine training for swift water rescue

techniques during my training. I am board certified in Emergency Medicine with an additional subspecialty board certification in EMS from the American Board of Emergency Medicine (ABEM).

4. What do you hope to accomplish during your term of service?

I hope to assist in the continued delivery of optimized prehospital care to the people of Hawaii that aligns with national recommendations and evidence-based practices from scientific literature. I'm particularly interested in evaluating whole blood deployment in the field, and mass casualty response.

5. Name three qualities that best describe you and how these qualities will the Emergency Medical Services Advisory Committee.

Collaborative - I am a team player and feel we all achieve more when we can recognize different and complementary skill sets. We can then more efficiently integrate them and bring the best of our abilities to constructive action.

Pragmatic - I care significantly more for the realistic achievement of solutions for needs than for the traditional or more idealistic route that may fail to achieve resolution. If something no longer works, finding a solution that accomplishes what it was meant to do should be the goal. **Tenacious** - Perhaps stubborn may be more accurate a description, but once an important action is identified, it takes much more than difficulty or complexity to to discourage me from pursuing it.

6. Name a previous experience you've had that will be beneficial as a member.

I was involved in the pre-event planning for the Masters National Golf Tournament in Augusta and participated in coordinating medical support for large multi-agency operations for gang arrests (Old Savannah Road Gang, 7 Crown gang) and participated in a massive (\$220 million estimated operation) human trafficking ring in Coffee County, GA with involvement from Homeland Security, FBI, FBI, ATF, and other local police and sheriff agencies.

7. Can you foresee any possible conflicts of interest that could arise during your service on the Emergency Medical Services Advisory Committee. How would you overcome conflicts of interest?

I do not anticipate or currently have any conflicts of interest and would follow the applicable regulations and codes of conduct to resolve any that develop.
