Testimony in Support of Major Aris A. Banaag for Representation on the State of Hawaii Committee on Military and Veterans Affairs

Aloha Chair, Vice Chair, and esteemed members of the Committee on Military and Veterans Affairs,

My name is Sharon Banaag, and I am honored to submit this written testimony in full support of my husband, Major Aris A. Banaag, for a seat representing Maui County on this committee. I firmly believe that there is no one more qualified for this position, given Major Banaag's extensive and diverse military background, leadership experience, and unwavering commitment to serving both our state and nation.

Major Banaag's military career has come full circle. He began his service as an enlisted member of the United States Air Force and later transitioned into the Army, where he earned his commission as an officer. A Deep Commitment to Community and Public Service

He personally put himself through college at UH Mānoa using his Montgomery GI Bill, balancing both military service in the Army National Guard and his education. He successfully earned his bachelor's degree in psychology, later going on to complete his master's degree in family counseling.

His dedication to helping others extended into his civilian career, where he became the first-ever mental health counselor at UH Maui College. In this role, Major Banaag directly supported hundreds of students of all ages, guiding them through personal challenges and ensuring that mental health services were accessible to the student body. His passion for helping youth was evident long before this role—he previously managed multiple facilities that supported troubled youth, always working to uplift and guide those who needed support the most.

Even while balancing his military and professional responsibilities, Major Banaag has never hesitated to serve his community. He has coached basketball, track, and other sports, always stepping up whenever Maui's youth needed a mentor or leader. His leadership extends far beyond the sports field—he has chaired numerous nonprofit initiatives and community movements, including:
