- 15 provider seats in OSAB, which covers both urban and rural communities. She currently works as

a Federal Public Defender in the District of Hawaii, bringing her extensive experience and
 knowledge to the Board.

Jacquie Esser is currently serving her first term as an OSAB member. It was welcomed news that she applied for a second term. She is an active listener and an effective participant at OSAB meetings. She will bring the knowledge from her current term, including a fuller grasp of our behavioral health landscape and the available community resources needed to reach consumers through better alignment, communication, and stigma-reduction. It will be a boost to prevention efforts to have someone of her caliber on the OSAB, for she has deep knowledge and appreciation of the complications and costs that can exponentially arise when individuals who have mental illness get entangled further with the criminal justice system.
