- 1. I am interested in joining the Emergency Medical Service Advisory Committee to acquire a comprehensive understanding of innovative strategies for enhancing pre-hospital care. My objective is to share insights gained from my experiences on the 911 ambulance and to engage in discussions focused on improving the overall emergency care system, particularly in relation to the retention and recruitment of paramedics and EMTs, as well as the effective allocation of resources.
- 2. This committee serves as an advisory body to the Department of Health on matters impacting Hawaii's pre-hospital emergency care and emergency services.
- 3. With nearly 21 years of dedicated service to Honolulu Emergency Medical Services, I commenced my career as an EMT providing essential life support before advancing to the position of paramedic, where I delivered advanced medical life support. Subsequently, I undertook supervisory roles, providing oversight for Advanced Life Support (ALS) within the aging unit and facilitating the training of new recruits, including EMTs and paramedics. Currently, I hold the position of District Chief, managing multiple units and personnel on a daily basis. Furthermore, I have actively participated in union activities, serving as a steward and chief steward over several years, collaborating with the union (UPW) and management to enhance working conditions within the high-volume Honolulu EMS system. I am acutely aware of the national shortage of paramedics and EMTs and aspire to contribute to addressing these concerns while improving the quality of pre-hospital emergency care.
- 4. I look forward to learning from fellow committee members and gaining insights about optimizing Honolulu EMS operations. Additionally, I aim to share my experiences, perspectives, and strategies, and I welcome constructive feedback to refine these ideas. I am committed to advancing Honolulu EMS, particularly given the high call volume we encounter and the training opportunities we provide to other islands.
- 5. I believe that my daily interactions with colleagues, management, and patients cultivate an environment of honesty and dedication to my role. I recognize the critical importance of these professions in serving the community and am motivated to ensure that current and future professionals in this field can fully dedicate themselves to their work, underpinned by strong organizational support.
- 6. Recently, I undertook the initiative to establish a separate bargaining unit for Honolulu EMS, a significant effort aimed at creating a dedicated platform to address the specific concerns of paramedics and EMTs. This endeavor necessitated nearly four years of collaborative efforts with both the union and legislators. I was driven by the conviction that the profession deserves focused attention to effectively devise and implement improvements within our system, encompassing employee concerns from all perspectives, including mental health.

7. As this will be my first experience serving on this committee, I do not foresee any immediate challenges. However, should any issues arise, I will address them transparently with the committee, seeking guidance to resolve conflicts effectively. My intention is to serve with integrity, ensuring that my actions and efforts align with the highest standards of professionalism throughout my term.
