### (1) Why do you wish to be the Chairperson - Hawaii Labor Relations Board?

Being the Chairperson would allow me to continue the work that I have engaged in throughout my career. I have been fortunate enough (primarily due to the efforts of many others) to serve for twenty six years in the State Legislature. Six years were spent chairing the House Committee on Labor and Public Employment, and two have been spent leading the Senate Labor Committee.

These two experiences have been an integral part of my educational experience in the Legislature. Those eight years in particular (along with serving two more years as the Vice Chair for the House Committee on Labor and Public Employment) broadened my understanding of the labor laws in Hawaii. I also learned a lot about the various labor laws, including Collective Bargaining Rights, Workers' Compensation, Unemployment Insurance, OSHA,TDI, Prepaid Health, Civil Service, and other laws that establishes rights and benefits.

I have also spent an additional eight years (of those twenty six) serving as the House Finance Chairman. These experiences have not only allowed me to learn much about Hawaii's labor laws, but have allowed me to gain insight in determining what "legislative intent" is, which has governed many of the changes that have occurred to those labor laws. These experiences have also taught me how the Department of Labor and the other state departments interconnect, especially when it comes to funding.

"The Legislature declares that it is the public policy of the State to promote harmonious and cooperative relations between government and its employees and to protect the public by assuring effective and orderly operations of government." (emphasis added).

Serving as the Director taught me much about being part of management, and how critical it is to be able to work with many parties, to achieve major goals. (2) How do you perceive the role and responsibilities of the Chairperson - Hawaii Labor Relations Board?

The role of the Chairperson for the Hawaii Labor Relations Board is described in Chapter 89-5(b), which states:

"(b) The board shall be composed of three members of which one member shall be representative of management, one member shall be representative of labor, and the third member, the chairperson, shall be representative of the public." (emphasis added).

If there is a deadlock between the management representative and the labor representative, the Chairperson will break the tie, and his "perspective" will be as a "representative of the public" or what is considered in the best interest of the community. This is usually what guides most legislators, as they cast their votes.

Moreover, in applying the law to various factual circumstances, discerning what "legislative intent" was - when the legislation was passed or amended, becomes a key part of the decision-making process. That is why having experience in both the administrative and the legislative branches of government - is an advantage that assists in decision making.

Further, as Chapter 89-1(b) reminds us - promoting harmonious and cooperative relations between Government and its employees means protecting "the public by assuring effective and orderly operations of government" (emphasis added) or to maintain labor peace, which should minimize any disruption of government services to the public. This is an important goal of the Hawaii Labor Relations Board.

The Hawaii Labor Relations Board is responsible for three chapters in the Hawaii Revised Statutes. As reflected in the HLRB 2024 Annual Report,

"The mission of the Board is to enforce and protect the rights of employees and unions to organize and bargain collectively, in balance with the employer's rights to manage operations as provided by HRS Chapters 89 and 377, by fairly and efficiently resolving labor disputes brought before it. The Board is committed to promoting the harmonious and cooperative relations between the parties." (emphasis added).

The Report also references HRS Chapter 396 (the Hawaii OSHA law) and continues,

"In 2002, the Board acquired jurisdiction over contests relating to occupational health and safety. Accordingly, the Board is committed to ensuring that every worker has a safe and healthful work environment, and that employers and employees collectively work to reduce injury and illness arising out of Employment." (emphasis added).

The Report further explains,

"The Board also has jurisdiction over private sector employees, employers, and unions who are not subject to the jurisdiction of the National Labor Relations Board. Historically, this has included agricultural employees and employers."

"The Board also conducts union representation elections, supervises the impasse procedures in public employment, and issues declaratory rulings, which clarify the applicability of governing statutes and its rules."

Under all three Chapters of the HRS, the Chairperson of the Board should be leading in the proper enforcement of the laws, and should provide leadership where necessary, to amend or adjust the laws.

(3) Given your understanding of the role and responsibilities of the Chairperson - Hawaii Labor Relations Board why do you believe that you are qualified for the Position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as the Chairman.

I believe that I am qualified for the position of Chairman of the Board, because of three decades of practicing law, (most of which dealt with administrative law), has made me familiar with the substance and the procedures of labor law. This has included not only the skills necessary to practice before the HLRB, but skills to handle workers compensation cases (before the Labor and Industrial Relations Board), unemployment insurance cases (before the U.I. Referee's office), and other labor law cases.

This meant drafting memoranda in support of specific motions, and conducting investigations on cases, and analyzing cases to determine the best approach for hearing purposes. It meant preparing for oral argument, and conducting necessary legal research. It included working on and improving writing skills, a fundamental factor in the practice of labor law. I believe all of these activities helped me - to gain the skills and the understanding to become a labor attorney.

I believe that I am qualified, in part due to being involved in the legislative process, (for twenty six years as a Legislator and for four more years as the Labor Department Director). Through these experiences, I believe I had a good grounding in understanding the labor laws, its history, and how these laws were amended and came into being (legislative intent).

When workers compensation was the legislative "crisis" in the mid 1980's I learned from that experience, When civil service reform was the priority in 2000, I learned from that experience. When the unemployment insurance fund went bankrupt, due to the

downturn in the national economy, I learned from that experience. Each educational experience provided me with more information, and the cumulative impact of all of these experiences led to developing greater familiarity in the area of labor law. I consider my thirty years invested in the legislative process as time well spent. It was not only the knowledge that I gained - but the long-term relationships that would reflect the true value of that period in my life.

The four years spent as the Director of the Department of Labor was probably the most instructive in my career. Learning about the dozen or so programs (under the Department) and how they worked together to provide a wide range of services to the general public, did clarify the rights and the benefits these laws provided to both employees and employers. This included the Hawaii Labor Relations Board. I remember interacting with Jim Nicholson, the Chairman of the Labor Board at that time. We discussed the Board's budget and its staffing and the existing backlog of cases. We also talked about ways to improve the operations of the Board and how additional improvements could be implemented.

These discussions also included the Hawaii OSHA (HIOSH) law, and the fact that we were short-staffed for inspectors at that time. That situation allowed us to reach out to our federal partners, and establish training programs that helped to strengthen our HIOSH program, and provided greater coordination between the efforts of the federal and state OSHA personnel. It also gave me a keener appreciation of how important safety is, especially on the job site, and that effective enforcement was critical to cutting down the number of injuries and the number of deaths. The overall results of this kind of cooperation demonstrated the greater effectiveness of working together.

## (4) What do you hope to accomplish during your term of service?

I believe the first step is to get to know the parties that the Board will be dealing with - which includes the public unions as well as the public employers. I interacted with many of the parties during my legislative work. If there are any "projects" that the Board undertakes or "reforms" that the Board implements, it will probably be as a result of requests made by these parties.

One example that has surfaced is a request that the list of arbitrators and mediators (and the selection process) be made more transparent. As a result, a meeting of all the parties has been scheduled for March 10, 2025. The purpose will be to discuss concerns and then to set up a process for determining what improvements can be made. The initial concerns that have been expressed include competence of the

members on the list, costs assessed by these arbitrators, and adequacy of the number of arbitrators on the list.

Greater familiarity over time, will allow other concerns to be brought up by the parties or by events that occur - which will make the parties focus on procedure or substance - of the "rules" that governs the Board's actions. This kind of interaction is a crucial dynamic, for identifying relevant and significant concerns that the Board can begin to address.

(5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit as the Chairman - Hawaii Labor Relations Board?

The first quality is that I have a collaborative leadership style. This allows me to bring people together to resolve differences. This could mean bringing together the two other Board members (or bringing them together with staff) to build consensus in the decision making process. It could also bring the parties together as indicated in 89-1(b) "to promote harmonious and cooperative relations between government and its employees".

I have used this approach during my legislative work as well as my administrative experiences, and have enjoyed some success with it. It was a leadership style I utilized during my legislative days with many of my constituents, and it applied even in the context of working with State, County, and Federal agencies.

The second quality would be involvement in the legislative process for over thirty years, and learning from the process and developing many enduring relationships. Having worked with legislators who worked on many of the labor laws, like Senator Brian Kanno (former Senate Labor Committee Chairperson), Representative Mark Nakashima (former House Labor Chair), Senator Mazie Hirono (former member of the House Labor and Public Employment Committee), and Senators Aquino and Moriwaki, both the current Chair and the former Chair of the Senate Labor and Technology Committee, has provided me with much information and knowledge, and a better understanding of what is "legislative intent". This will be a key concept in properly interpreting and applying the law as the Chairperson.

Finally, one quality that I have been taught, especially by my father, is that you commit yourself to working hard in something that you truly believe in. This has been an important life lesson for me. Throughout my career and my life - I have been

passionate about how the law affects peoples' lives. I have seen so many successful examples of how it became a "tool", that people used to fulfill their highest potential, and how in many cases it "leveled" the playing field. I have seen it make **equality** more meaningful, and how it has facilitated a better quality of life. I am committed to doing all that I can, to do the best job possible, as Chairman of the Hawaii Labor Relations Board.

## (6) Name one previous experience that would make you stand out. How would this benefit as the Chairman - Hawaii Labor Relations Board?

In 1994, while I was serving as State Representative for District 1, two plantations closed their doors for the final time - they were the Hamakua Sugar Company and Hilo Coast Processing Company. Over a thousand families, living along a fifty mile coastline were dealt a tremendous body blow. All of a sudden there was so much uncertainty for these people and their communities. The two plantations had provided the economic means for these families to meet their financial obligations for over a century. How would they pay for their mortgage payments and college expenses? The one thousand workers included many family members and many friends - real people that we had personal relationships with.

This was the biggest challenge I had faced while serving as an elected official. There was no "blueprint" that we could use. It was a matter of trying to bring resources into the community, to keep hope alive. So we rolled up our sleeves and started. We partnered with every organization we could. This included the ILWU Local 142, the churches in the communities, and many other groups.

It meant working with the unemployment insurance staff as well as workforce development (for training programs) from the Department of Labor and Industrial Relations. It meant reaching out to State, County, and the Federal governments and also to "grass roots" organizations. The Department of Health helped, as the drinking and amount of stress within families increased, and many private non-profits added their assistance. Being rural communities meant agriculture was part of the lifestyle, and the Department of Agriculture was there to lend a helping hand.

It was a matter of trying to manage the overall efforts through task forces, that tried to take a piece of the whole, and helped to provide leadership in that area. Leadership, especially during times of confusion and uncertainty, is of critical importance.

This experience resulted in a wealth of knowledge with so many lessons learned. Included in these lessons were how to find common ground, and how to best work together as a team, especially during a crisis. Also important, was how to build consensus, and get projects completed that will make the community more resilient to the next crisis. Providing leadership that focuses on teamwork and building consensus, will be an essential tool for the Chairperson.

(7) Can you foresee any possible conflicts of interests that could arise during your service as Chairperson - Hawaii Labor Relations Board? How would you overcome any possible conflicts of interest?

I have been on "retirement status" for the past several years, and have not been actively engaged in the kind of decision making that would create a conflict in interest. However, if there were to be a conflict of interest in a case that came before the Board, and I felt I could not make a fair and impartial judgment, then I would recuse myself from that decision.


