



RE: Governor's Message – GM581 - Hawai'i Workforce Development Council

1. Why do you wish to be a member of the Hawai'i Workforce Development Council?

I wish to serve on the Hawai'i Workforce Development Council (WDC) to contribute my expertise in workforce development, community engagement, and legislative advocacy to help strengthen Hawai'i's workforce pipeline. Through my work at the Hawai'i Lodging & Tourism Association (HLTA), I have actively participated with initiatives that connect students and job seekers with career opportunities in the visitor industry. I see WDC as a critical platform to expand these efforts across multiple sectors, ensuring that Hawai'i residents have access to meaningful employment, training, and professional development opportunities.

By leveraging my experience in public-private partnerships, scholarship and internship programs, and advocating for workforce-friendly policies, I hope to help align workforce strategies with the state's economic priorities while addressing employment gaps and career pathway challenges for local workers.

2. How do you perceive the role and responsibilities as a member of the Hawai'i Workforce Development Council?

As a member of the Hawai'i Workforce Development Council, I understand that my role would be to advise on workforce policies, promote employment initiatives, and help align workforce development efforts with the state's economic needs. This includes:

During my term, I hope to:

- Expand workforce development initiatives that bridge the gap between education and employment, particularly in hospitality, tourism, and other growing industries. This includes bringing the tourism industry at large to the table, ensuring that their need for skilled and dependable employees is addressed through WDC initiatives.
- Advocate for stronger partnerships between the private sector, educational institutions, and government agencies to ensure job training programs are aligned with real workforce demands. I aim to support and expand public-private

partnerships that provide internships and career development opportunities for Hawai'i's local youth.

- Improve access to career pathways and professional training for local workers by opening up pipelines that allow job seekers to more easily connect with employment opportunities across different sectors.
- Educate businesses, particularly those in the tourism industry, about the resources available through WDC and WDD, ensuring they can take full advantage of training programs, workforce development initiatives, and hiring support services on a larger scale.

5. Name three qualities that best describe you and that would make you stand out. How would these qualities benefit as a member of the Hawai'i Workforce Development Council?

- Strategic Thinker – I have a strong ability to develop and implement forward-thinking workforce strategies that align with Hawai'i's evolving economic landscape. By anticipating industry trends and workforce needs, I can contribute innovative, data-driven, and practical solutions to WDC discussions that directly address labor shortages and skills gaps.
- Collaborative Connector – My extensive experience working across public, private, and nonprofit sectors allows me to foster partnerships that drive impactful workforce development initiatives. 6. Name one previous experience that would make you stand out. How would this benefit as a member of the Hawai'i Workforce Development Council?

One of my most impactful experiences has been my critical role in supporting and executing HLTA's workforce development initiatives, particularly the Visitor Industry High School Internship Program and Generational Mentoring Program. 7. Can you foresee any possible conflicts of interests that could arise during your service as a member of the Hawai'i Workforce Development Council? How would you overcome any possible conflicts of interest?

As a Vice President at HLTA, my role involves advocating for the visitor industry's workforce needs. While I do not perceive any potential conflicts of interest, I would manage this by:

- Ensuring transparency in all discussions and decision-making by fully disclosing any potential conflicts before engaging in workforce policy decisions.
- Approaching workforce issues from a broad, multi-industry perspective, advocating not just for tourism but for policies that benefit Hawai'i's entire workforce.
- Recusing myself from discussions or votes where a direct conflict exists, while still contributing valuable insights from my experience in workforce development.

I am committed to serving the greater good of Hawai'i's workforce and would uphold ethical decision-making in my role on the WDC.
