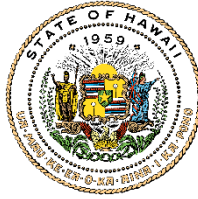

HAWAII HISTORIC PLACES REVIEW BOARD, GUBERNATORIAL NOMINEE,
ADRIANE TRULUCK, FOR A TERM TO EXPIRE 06-30-2028**

The Department of Land and Natural Resources recommends Senate confirmation of the appointment of Adriane Truluck to the Hawai'i Historic Places Review Board.

The Hawai'i Historic Places Review Board was established under Section 6E-5.5, Hawai'i Revised Statutes, to evaluate and determine if historic properties are to be entered into the Hawai'i Register of Historic Places and by which nominations of historic properties to the National Register of Historic Places will be approved by the Board. Adriane Truluck is nominated to serve as an Architecture specialist on the Hawai'i Historic Places Review Board. If confirmed, Adriane Truluck will serve until June 30, 2028.

Adriane Truluck is a licensed Landscape Architect and Secretary of Interior Qualified Historian with over 20 years of experience in research, treatment, management, and design of historic resources. She currently serves as a Historical Landscape Architect at AECOM in Honolulu, where she manages cultural and historic landscape projects for clients such as the National Park Service, the US Navy, and the State of Hawai'i. She specializes in cultural landscape research, historic evaluation, treatment and design, and Federal and State historic resources compliance. Additionally, Ms. Truluck has served as a lecturer at the University of Hawai'i at Mānoa, teaching cultural landscape topics. She holds a Master of Landscape Architecture with a Certificate in Historic Preservation from the University of Virginia and a Bachelor of Arts in Geography-Anthropology from Vassar College. She serves on the Board of Trustees for the Historic Hawai'i Foundation and has participated in various preservation and

environmental organizations. She has also presented at national conferences and authored publications on cultural landscape preservation.

Ms. Truluck's background, experience, and contributions to identify, document, and preserve historic and cultural resources in Hawai'i evidence her ability to serve faithfully and well on the Hawai'i Historic Places Review Board. We are happy to support her nomination.
