She understands that restorative justice and vocational training are essential in breaking the cycle of incarceration and providing opportunities for formerly incarcerated individuals to reintegrate into society with dignity and purpose.

Her ability to build pathways to employment, secure partnerships with private businesses, and provide culturally responsive job training is precisely what is needed to reduce recidivism and uplift Hawai'i's most vulnerable populations.

The need for culturally relevant rehabilitation programs cannot be overstated. Native Hawaiian women make up 44% of the female incarcerated population in Hawai'i, despite only comprising 19.8% of the general female population. This is a profound injustice that must be addressed through intentional policies, workforce initiatives, and strong leadership, all of which Ms. Kobashigawa is well-equipped to advance.

Her prior work as Deputy Director in the Governor's Office of Constituent Affairs and her tenure at Catholic Charities Hawai'i showcase her deep commitment to public service, community engagement, and social justice. Additionally, her current role as School Official and Compliance

Officer at Applied Computer Training & Technology, Inc. has allowed her to assist underserved students, including veterans, in obtaining certifications and employment, a critical skill set that directly applies to HCI's mission of providing incarcerated individuals with economic opportunities.

Rehabilitation, reintegration, and the opportunity to rebuild one's future all begin with access to meaningful work and education.
