(1) Why do you wish to be a member of the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances?

To better understand how to meet the mental health needs of the Medicaid population in Hawaii.

(2) What do you perceive are the roles and responsibilities of a member of the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances?

As an advocate for the needs and health disparities of the citizens of Hawaii suffering from a Substance Use Disorder (SUD). Additionally, I would also wear an alternate advocate 'hat' on for those in the Medicaid population suffering from SUD.

(3) Given your understanding of the roles and responsibilities as a member of Hawai'i Advisory Commission on Drug Abuse and Controlled Substances, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, and knowledge that would aid you as a member of the board.

I have worked in healthcare in Hawaii all of the nearly 36 years of my professional career and have a good understanding of the health care delivery system in Hawaii. Working for Medicaid for the past 19 years has given me an appreciation of the difficulties faced by Medicaid members who are struggling with an addiction related to an SUD. At Medicaid, we have worked specifically to target policies and stand-up programs that address the needs of those struggling with SUD. My work has exposed me to the difficulties with adequate provider capacity to deliver Medication Assisted Treatment services, especially on the neighbor islands. Finally, my past 3-year term as a member of the Hawaii Advisory Commission on Drug Abuse and Controlled Substances has given me vital experience with leveraging the voice of the Commission to advocate for those suffering with SUD.

(4) What do you hope to accomplish during your term of service?

I hope to improve the lives of Hawaii residents who struggle with additions and SUD. Additionally, I hope to fortify and strengthen the collaboration between

ADAD and MQD to coordinate our efforts to better serve the people of the State of Hawaii.

(5) Name three qualities that best describe you and how these qualities will the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances?

Steady, good listener, collaborator. I hope my steadiness will help moderate the decisions of the Commission, so as to not lurch to assumptions or trends that may not be beneficial in the long term. I will listen to all constituencies and the experiences that they are struggling with and will consider all voices as decisions are made. Collaborating with other Commission members will facilitate transparent communication and informed decision making.

(6) Name a previous experience you've had that will be beneficial as a member?

Working as the Health Care Services Branch Administrator (HCSBA) for the Med-QUEST Division (MQD) or the past 9+ years has exposed me to the many struggles that member of our community face as they struggle with addiction and the impacts it has on their everyday life. As MQD has rolled out our Community Integration Services program that provides pre-tenancy and tenancy sustaining services to Medicaid members struggling with homelessness, many of those in this program have had their SUD diagnosis impact their ability to find a place to call home and adapt their behavior to what is normally expected from a tenant in good standing. As a part of the screening process when members enter the CIS program, there are specific questions related to any SUD conditions so that the CIS provider is aware and can ensure specific supports are in place for a successful placement. Additionally, MQD have begun to enroll clean and sober homes as CIS providers so that those struggling with an addiction can also benefit from CIS services. MQD has also receive recent approval through our 1115 waiver process to begin providing Contingency Management services to our Medicaid members. This new benefit is grounded in over 30 years of evidencebased research, provides a series of motivational incentives for meeting treatment goals, and is available to Medicaid members that have a qualifying SUD diagnosis and who meet other eligibility criteria. MQD has also partnered with ADAD to strategize how Medicaid can pay for a greater proportion of the ADAD payments made to SUD provider, by tapping into the federal match open to services paid by Medicaid and subsequently 'stretching' how far the scarce State general fund dollars might go. We are looking at removing barriers that keep these providers from billing a Medicaid health plan for their SUD services, and are also working through sharing enrollment information with ADAD so they can be aware of when providers have failed to bill Medicaid health plans for these services. My past 9+ years in the HCSBA position has shown me the many challenges and opportunities that are present in our current delivery system for those who struggle with SUD.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances. How would you overcome conflicts of interest?

I do foresee possible conflicts of interest, for instance in my past tenure when the Commission voted on whether to support proposed legislation that is supported by the Hawaii Medicaid program. In these past instances where there was a potential conflict of interest, I have recused myself from voting on that specific piece of legislation. If it becomes necessary for me to step down because of a certain potential conflict of interest that cannot be avoided by a simple recusal, then I would gladly step down to avoid any impression of my conflict of interest tainting the Commission's decisions.
