Aloha Chair Joy A. San Buenaventura:

Thank you for this opportunity to provide responses to your questions regarding my nomination for the Director of the Department of Human Services. It is an honor to be nominated by Governor Green and be part of the DHS team.

1. Why do you wish to be Director of the Department of Human Services?

It is a great honor to be able to work in the Administration and partner with the Legislative Branch to support the people of the State of Hawaii. I am born and raised local boy with deep roots in our community and that has fostered a life-long commitment to improve the quality of life for our keiki and their ohanas. Throughout my career, I have emphasized the value of family, importance of social services and advocacy for policies that support people during various life challenges. I desire to serve as the Director because it is responsible for the operations, performance and vision of an organization that directly supports the lives of our families in Hawaii.

To be the Director of the Department of Human Services (DHS) is an opportunity to lead a value driven department that provides essential services to those who may be struggling. As Director, I can utilize my experience as a policy maker, social worker,

educator, and community leader to better the lives of families across our State. The role of the Director is a challenging one that would require that person to develop and improve the state's services to the most vulnerable ohanas and achieve the best quality of care possible. I wish to be the Director to support the mission of DHS which is "to provide timely, efficient and effective programs, services and benefits for the purpose of achieving the outcome of empowering Hawaii's most vulnerable people; and to expand their capacity for self-sufficiency, self-determination, independence, healthy choices, quality of life, and personal dignity." This honor would allow me to continue my passion for public service and be able to support the needs of Hawaii's people.

2. What do you perceive are the roles and responsibilities of the Director of the Department of Human Services?

The Director of the Hawaii's Department of Human Services plays a critical leadership role in ensuring the delivery of essential federal and state programs to our most vulnerable populations, including our keiki, our kupuna, people with disabilities, and struggling low-income families. Responsibilities of this position include managing a large and diverse workforce, overseeing a \$4 billion dollar budget, developing and implementing policies passed by our State Legislature, ensuring compliance with State and Federal regulations, and advocating for needed resources. The Director is also expected to collaborate with various community organizations, numerous Federal/State/County government entities, and non-profit stakeholders to reduce barriers affecting the community, such as those experiencing poverty, homelessness, and lack of healthcare accessibility.

The Director of DHS is also responsible to communicate with our key partners in working collaboratively on addressing our community's needs. This role requires an open and collaborative relationship with our legislature, ensuring that the budget is addressed to support service delivery and to ensure that legislative policies passed are implemented to support the people of Hawaii. All of our State Directors need to be effective communicators, educators, advocates, and collaborators.

3. Given your understanding of the roles and responsibilities of the Department of Human Services Director, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, and knowledge that would aid you as a member of the Board.

As a leader with 30+ years of various professional experiences in both the public and private sectors, and serving in multiple levels of management with various

responsibilities, I believe I am qualified for the position. I have a background in public service, academia, non-profit human services, and various healthcare systems. I strive to be an engaging and dynamic leader who excels in various situations and with a wide range of stakeholders. During my 18 years of at the Legislature, among other committees, I specifically served as the former Chair of Health and Human Services in the Hawaii House of Representatives. These experiences gave me the opportunity to work with my legislative colleagues on executive level policies and assist during various crisis, including COVID and the national budgetary downturn in 2008. Additionally, I had participated in various executive level educational programs and developed my skills in communication, executive management, and mediation.

Prior and during my time at the Legislature, my decades of service as a social worker have afforded me a wealth of experience working with a diverse range of clients, across Hawaii as well as other states. My various professional social work roles include work with a variety of multidisciplinary teams, management of complex cases and navigating intricate health care systems. Over time, I had the privilege of supporting keiki and ohanas during crisis, individuals dealing with substance abuse and mental health struggles, and working on case management and crisis intervention to those of all ages. Helping people during very challenging times requires a high level of empathy, resilience, and focus. Seeing those in need overcoming barriers and improving their quality of life to find their own solutions has been one of the most fulfilling parts of my social work career.

Throughout my elected and social work career, I have had the opportunity to work with great interdisciplinary teams to analyze complex issues and implement solutions that ensured equitable and sustainable public service. The Human Services Director has a great responsibility to be that collaborator to work with our Governor, Legislators, and our Administrators to build a strong safety net for our community.

My brief statement would be: "I believe I am qualified for this very important position because of my extensive professional and personal experiences in social services. This includes working at an executive level, having diverse experience in leadership roles, and my ability to develop and implement strong relationships. My background in public health and community development has equipped me with the knowledge and expertise needed to address the numerous needs of our diverse population across our State. I will strive to use my skills in communication, planning, and team collaboration to help build a successful department."

4. What do you hope to accomplish during your term of service?

I hope to implement changes that improve the lives of those we serve. The people of Hawaii and our legislators deserve leaders who are committed to listening to the voices of our communities and reducing barriers to services for our keiki, kupuna and underserved population. I would like to streamline service delivery, reduce bureaucratic delays, increase transparency and work with the community to expand our service array. As the Director, I intend to enhance efficiencies, improve our workforce, maximize our resources, and justify to the legislature how we effectively use our resources. DHS staff are our connection to our communities, so I would like to increase trainings, provide them service supports and equip them with resources that protect and support those we support.

When I was asked what my legacy would potentially be while I served as Director, I hope it would be that “my term was marked as a time when the department was efficient, effective, and successful in providing essential services to the people of Hawaii. During this period, areas of child welfare, income support and staff development flourished with improvements in quality care and staff support.” I hope that during my term I would have earned the legislature’s trust and that DHS has promoted a culture of excellence and compassion.

5. Name three qualities that best describe you and how these qualities will benefit the Department of Human Services.

DHS deserves a dynamic leader who can support and lead during challenging times. The Director should be versed in various skills and the three that best describe me is empathy, leadership and analytical problem solving.

Empathy: I believe I have the ability to understand and deeply connect with various individuals and hearing their experiences enables me to relate to those who we serve. As you can see from my resume, I have held diverse positions and participated in many programs that have given me a multitude of experiences where I was able to assist communities in need. Being a part of these experiences have helped shape my understanding of diversity of human needs. This quality of relating to people helps me remain focused on prioritizing the needs of our vulnerable populations in decision-making.

Leadership: I strive to promote a collaborative leadership style that fosters a positive, solution-oriented environment that encourages communication and teamwork. I have found that this skill helps to motivate a team focus and encourages people to work together toward common goals of supporting keiki, kupuna and our communities.

The goal is to inspire and guide all our DHS team toward fulfilling our mission and supporting others.

Analytical Problem-Solving Thinking: My diverse professional and educational background has supported my development in being adept at evaluating complex situations and developing collaborative solutions that build consensus. This mindset helps me consider both evidence-based data and include practical real-life experiences in planning potential solutions.

6. Name a previous experience you've had that will be beneficial as a member.

In my volunteer role with American Red Cross Disaster Mental Health, I was called to serve following a heart-breaking incident involving the shooting of students at a school in Florida. In preparation to support the community, I had to mentally and emotionally reflect and become “pono” with the role as a disaster responder. As soon as I arrived, my role changed and I led the mental health response on-site of the memorial park. My commitment was to listen and care for survivors, listen and support the community and staff, and provide an empathetic and open environment. This experience taught me that listening was the greatest tool to supporting people and building trust. Once trust was established, we were able to work together with local officials, develop new policies, partnering with public-private entities began, and healing started.

I have other experiences that can highlight examples of my management, stakeholder engagements, resource development and leadership, however, my greatest honor from past experiences is based in the relationships that I have had the privilege of having.

7. Can you foresee any possible conflicts of interest that could arise during your service in the Department of Human Services? How would you overcome conflicts of interest?

I do not foresee any conflicts of interests being the Director of DHS. It is essential to maintain transparency and integrity throughout the time of public service. If conflicts of interests arise, I will disclose them and work on ensuring that my position does not bias any action or decision. During the interim period as Director, I have fostered weekly meetings with our Attorney General’s Office to review current actions in the Director’s office and help build ethical standards of conduct.

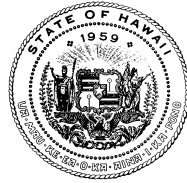

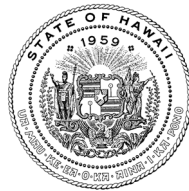
3 Mr. Yamane has years of experience in the field of social work, has earned the trust of his

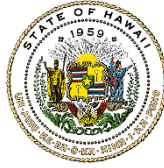

The Department of Labor and Industrial Relations **strongly supports** the confirmation of Ryan Yamane as Director of the Department of Human Services (DHS).

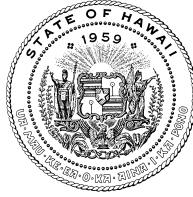

Comments:

I am writing as an individual in strong support of Ryan Yamane's appointment as the Director of the Department of Human Services (DHS).

I currently work for DHS and have had the opportunity to work with Mr. Yamane in his current role as the Department's Director, and also in his prior role as Chair of the House Committee on Health, Human Services and Homelessness. Mr. Yamane has a strong understanding of the Department and its mission. He has also demonstrated a willingness to listen directly to our staff to further his understanding. One of his first actions as Director was to reach out to the Division Administrators and schedule visits to see front line staff throughout the state.

Once again, I strongly support the appointment of Mr. Yamane. Thank you for the opportunity to testify.

Senator San Buenaventura and committee members,

As an advocate for families in the child welfare system for the last decade, I cannot support the appointment of Ryan Yamane as the Director of the Department of Human Services due to concerns about his leadership abilities and understanding of constitutional protections.

In November, DHS attended an information briefing to address an audit of Child Welfare Services and the final report of the Malama Ohana working group. Mr. Yamane's summary of CWS goals appeared to focus only on long-term objectives, including the ongoing issue of short-staffing and recruitment. Given the urgency of the foster care licensing failures, he did not present any immediate steps to address child safety. When asked about the department's funding requests, he replied that the department was "working on it." DHS could not explain the whereabouts of 10 million dollars in funding, except that various organizations meant to use the money to support hiring qualified staff were unsuccessful in finding new hires. Yamane and his two subordinates, Daisy Hartsfield and Elladine Olevao, attended the all-day Malama Ohana working group in-person event in August. They were also present at the November briefing but said nothing about the progress of the working group. Instead, the focus was on the long-term solution to foster placement through updated IT and a plea for help regarding safety from potential physical harm to the workers in the field and offices (with no specific incidents). A Director with strong leadership skills would recognize the urgency to provide more positive and detailed assurances from a department that has been the focus of a year-long working group aimed at reform.

In 2022, Mr. Yamane served as the chair of the HHH Committee, which processed HB2424 in response to the tragic death of Ariel Sellers. During the first hearing, testimony from the Attorney General raised concerns about the bill's language, specifically the term "expanded" investigative power, which suggested potential constitutional issues. Subsequent media coverage raised questions about these concerns, while Mr. Yamane assured us that the bill was proper. During the fourth conference committee meeting, Yamane stated, "We are going to maintain in here the checks for both adoptive and foster families." He also noted that there were questions about amendments to the bill that might affect the Hawaii Constitution, particularly the requirement to hold public hearings. On May 3, Mr. Yamane introduced a severability clause to the House floor "to protect the state" from a lawsuit.

On July 12, the Governor vetoed the bill, citing two concerns in writing: the privacy right violation of expanded home visits and the fact that the bill had been amended without a public hearing, which violated the Hawaii Constitution. I am not certain today, three years later, that the legislators involved in SB2424 understand the privacy rights in the Fourth Amendment as expressed by the Governor.

As a House Representative, Mr. Yamane ignored the constitutional rights of families in HB2424 despite having access to legal counsel. As DHS Director, he did not assure the Senate during the informational briefing that there would be proper screening of kinship caregivers to minimize risk of harm. It took 50 years to pass a measure aligning with the Fourth Amendment rights of all citizens, which is set to take effect on July 1, 2025. I have serious concerns that Mr. Yamane will not ensure the training and oversight necessary to protect the constitutional rights of families accused of child abuse or neglect and the transparency that the public needs from DHS is not promised or guaranteed.

As an advocate for families in the child welfare system for the last four years I Strongly Oppose the appointment of Ryan Yamane as the Director of the Department of Human Services due to concerns about his leadership abilities and understanding of constitutional protections.

In November, DHS attended an information briefing to address an audit of Child Welfare Services and the final report of the Malama Ohana working group. Mr. Yamane's summary of CWS goals appeared to focus only on long-term objectives, including the ongoing issue of short-staffing and recruitment. Given the urgency of the foster care licensing failures, he did not present any immediate steps to address child safety. When asked about the department's funding requests, he replied that the department was "working on it." DHS could not explain the whereabouts of 10 million dollars in funding, except that various organizations meant to use the money to support hiring qualified staff were unsuccessful in finding new hires.

In addition, Mr. Yamane, Daisy Hartsfield and Elladine Olevao, were invited to attend an all-day, in-person Malama Ohana working group event on August 19, 2024. At the time Mr. Yamane openly stated that he was, "committed to Child Welfare Reform." Yet, at the November informational briefing he said nothing about the progress of the working group. Instead, the focus was on the long-term solution to foster placement through updated IT and a plea for help regarding safety from potential physical harm to the workers in the field and offices (with no specific incidents). A Director with strong leadership skills would recognize the urgency to provide more positive and detailed assurances from a department that has been the focus of a year-long working group aimed at reform.

In 2022, Mr. Yamane served as the chair of the HHH Committee, which processed HB2424 in response to the tragic death of Ariel Sellers. During the first hearing, testimony from the Attorney General raised concerns about the bill's language, specifically the term "expanded" investigative power, which suggested potential constitutional issues. Subsequent media coverage raised questions about these concerns, while Mr. Yamane assured us that the bill was proper. During the fourth conference committee meeting, Yamane stated, "We are going to maintain in here the checks for both adoptive and foster families." He also noted that there were questions about amendments to the bill that might affect the Hawaii Constitution, particularly the requirement to hold public hearings. On May 3, Mr. Yamane introduced a severability clause to the House floor "to protect the state" from a lawsuit.

Finally, as a House Representative, Mr. Yamane ignored the constitutional rights of families in HB2424 despite having access to legal counsel. As DHS Director, he did not assure the Senate during the informational briefing that there would be proper screening of kinship caregivers to minimize risk of harm. It took 50 years to pass a measure aligning with the Fourth Amendment rights of all citizens, which is set to take effect on July 1, 2025.

In closing, I have serious concerns that Mr. Yamane will NOT ensure the training and oversight, transparency and accountability necessary to protect the constitutional rights of families accused of child abuse or neglect.
