Re: Responses for Nomination to the Language Access Advisory Council

## 1. Why do you wish to be a member of the Language Access Advisory Council?

With 23 years of experience as a Public Health Nurse, I have worked extensively with limited-English-proficient (LEP)communities, helping them to navigate health services. My firsthand experience has shown me the challenges LEP individuals face in accessing essential services.

After retiring from the Department of Health (DOH), I founded the Waipahu Safe Haven Immigrant/Migrant Resource Center in 2011 to provide in-language support for students and adults in the Waipahu area. My work has reinforced my belief that language access is critical in areas such as education, healthcare, housing and employment.

Hawaii's language access laws are essential, given that one in nine residents has limited English proficiency. I am passionate about improving resources for Hawaii's diverse communities and believe that my experience working with the Migrant Micronesian community will enable me to offer valuable guidance to the Council, ensuring the effectiveness of the state's Language Access Plan.

## 2. What do you perceive to be the roles and responsibilities of a member of the Language Access Council?

A primary role of a Council member is to evaluate, advise and enhance the State's Language Access Plan, ensuring its effective implementation across agencies serving the public.

Additionally, Council members should:

- Advocate for improvements if services are inadequate
- Support training initiatives for interpreters and translators to expand the pool of qualified professionals in Hawaii.
- Collaborate with state agencies to ensure compliance with language access laws.

3. Given your understanding of the roles and responsibilities of a Language Access Advisory Council member, why do you believe that you are qualified for this position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the board.

I have extensive experience working with LEP communities, in public health and in my current role as the Director of Waipahu Safe Haven Center. As a Public Health Nurse for 23 years, I developed health promotion initiatives for Micronesian communities in the Leeward area, including outreach and education for the Hansen's Disease Community Program.

Additionally, I collaborated with the University of Hawaii's Interpretation and Translation Studies Program to train 13 Micronesian interpreters who were bilingual in Chuukese, Marshallese, Palauan, and Pohnpeian languages. These interpreters are actively serving their communities.

I also chaired the Nations of Micronesian Community Committee at the Department of Health bringing together statewide stakeholders from health, labor, government and non-profits to bridge an understanding of the Micronesian community and develop partnerships with Micronesian groups to support the challenges they were facing including Language Access.

Through my current work at Waipahu Safe Haven Center, I remain deeply connected to the LEP community. My expertise, leadership and advocacy make me well suited to contribute effectively to the Council.

4. What do you hope to accomplish during your term of service?

During this term of service, I aim to:

- provide oversight and recommendations to the Language Access plan for state agency.
- Enhance community outreach by supporting the Office of Language Access in becoming more visible and accessible.
- Expand interpreter and translator training programs addressing the critical shortabe of qualified professional interpreters.

By leveraging my experience, I hope to ensure that Hawaii's LEP populations receive equitable access to vital services.

5. Name three qualities that describe you and how these qualities will benefit the Language Access Advisory Council.

- Commitment to the Community, I am dedicated in advocating for LEP populations and working collaboratively to enhance language access services.
- Team-Oriented Approach-I have experience working across multiple sectors, including schools, non-profits, and government agencies.
- Passion for partnership- I believe in collaborative solutions to ensure inclusive, languageaccessible services.

These qualities will allow me to effectively contribute to the Council's mission and work productively with fellow members.

## 6. Name a previous experience you've had that will be beneficial as a member.

During the COVID-19 Pandemic our Waipahu Community and other Migrant and Immigrant communities faced urgent challenges in accessing in-language health information quarantine guidance, and essential resources. Our interpreters received numerous requests from individuals seeking assistance with quarantine protocols, unemployment benefits and food access. Recognizing the critical need for language access, we collaborated with the Consulate Offices to stream in-language information on radio shows and on their social media platforms. We also organized food drives and distributed inlanguage information to 14,000 immigrant and migrant families via their food boxes. During Maui's wildfires, we partnered with the Marshallese Community Organization of Hawaii, Pacific Gateway, Office of Language Access and the People's Fund to coordinate emergency interpreter deployment to Maui. For the Maui response we successfully mobilized 17 Micronesian interpreters into Maui ensuring that affected families could access relief services.

This experience underscored the importance of language access in crisis response, and I am committed to strengthening Hawaii's preparedness in this area.

7. Can you foresee any possible conflicts of interest that could arise during your service on the Language Access Council?

I do not foresee any possible conflicts of interest however, if a potential conflict arises, I will recuse myself from discussions or decision making on that matter.

The Legal Clinic (TLC) supports Gubernatorial Nominee, Barabara Tom, for the Language Access Advisory Council (LAAC).

TLC is a Hawai'i nonprofit, nonpartisan organization. TLC is a direct legal services provider, representing those in Hawai'i who meet income eligibility guidelines without regard to immigration status, national origin, ethnic background, race, religion, ideology, gender identity, sexual orientation, age, or disability. TLC works alongside immigrants so they can attain authorization to work and live with dignity, reunite with their families after years of separation and escape horrific violence to find refuge in the United States. TLC recognizes that every person needs and deserves to feel a sense of trust, welcome, and belonging.

According to the 2020 U.S. Census, Hawai'i is the most diverse state in the nation.<sup>1</sup> In 2023, Hawai'i had about 256,000 immigrants, which is approx. 18% of the State population.<sup>2</sup> The top countries of origin for immigrants were the Philippines (45 percent of immigrants), China (9 percent), Japan (8 percent), Korea (6 percent), and the Pacific Island Nations (4 percent).<sup>3</sup>

There are between 41,000 -50,500 undocumented immigrants in Hawai'i.<sup>4</sup> Hawaii is the only state where undocumented women (55%) outnumber men.<sup>5</sup>

The work of the LAAC -- providing input on: implementation and compliance with Hawai'i's language access laws; the quality of oral and written language services provided under the law; and the adequacy of a state agency or covered entity's dissemination and training of its employees likely to have contact with Limited English Proficient (LEP) persons, its policies and procedures for language services, its competency in working effectively with in-person and telephone interpreters, and its understanding of the dynamics of interpretation between clients, providers, and interpreters<sup>6</sup> – is integral to the work of TLC. TLC cannot fully and effectively support our immigrant and migrant communities without LAAC.

Thus, TLC supports Gubernatorial Nominee, Barbara Tom, for LAAC. Ms. Tom is currently serving as a LAAC councilmember.
