The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> GM670, which would confirm Julian Ako for appointment to the Oʻahu Island Burial Council (OIBC). Mr. Ako applied for the OIBC through OHA as part of our 2024 IBC recruitment process. After internal vetting of candidates, the top respective candidates for respective IBCs were provided to the full OHA Board of Trustees (BOT) for approval on January 23, 2025. Approved candidates were then submitted to the Office of the Governor on January 28, 2025.

OHA is the constitutionally established body responsible for protecting and promoting the rights of Native Hawaiians.¹ As part of our constitutional and statutory mandate, OHA has been intimately involved with historic preservation related advocacy for decades and is granted specific kuleana under the Hawai'i Historic Preservation law, Hawai'i Revised Statutes (HRS) Chapter 6E, and implementing regulations.² Per HRS 6E-43.5, the Governor must select at least two appointees on each IBC from OHA's list of nominees.

Mr. Julian Ako is a retired Administrator and Principal of Kamehameha Schools and former Director of the Hawaiian Civic Club of Honolulu. He has served on various Boards and organizations, including the Hawaiian Historical Society, Ahahui 'Olelo Hawai'i, Pihana Nā Mamo Program, and Harvard University Principals Center National Advisory Board. Mr. Ako is also an 'Ōlelo Hawai'i speaker. Mr. Ako has direct experience with Hawai'i's burial processes and the administrative rules as he has completed the burial registration process for sites on Kaua'i, and is also a recognized cultural descendant. Familiarity with these processes is a valuable asset for IBC members to bring with them to the council.

For these reasons, OHA urges the Committee to <u>PASS</u> GM670, to confirm Julian Ako to the OIBC. Mahalo for the opportunity to testify.

In consideration of GOVERNOR'S MESSAGE 670
SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE ISLAND BURIAL COUNCIL, ISLAND OF O'AHU, GUBERNATORIAL NOMINEE, JULIAN AKO, FOR A TERM TO EXPIRE 6/30/2029.

The Department of Land and Natural Resources (Department) supports Governor's Message 670, nominating Mr. Julian Ako to the Island Burial Council, Island of O'ahu, expiring June 30, 2029.

The Island Burial Councils are established under Section 6E-43.5, Hawai'i Revised Statutes. The Councils determine whether to preserve in place or relocate previously identified native Hawaiian burials site, recognize lineal and cultural descendants, and provide counsel and advise to the Department. With the exception of the Moloka'i Island Burial Council, the island burial councils consist of no more than nine members, of which six representatives shall represent a specific geographic area, and no more than three shall be representatives of development and large landowner interests. Mr. Ako is seeking to represent the Kona geographic area.

Julian Ako is a lifelong resident of Kona moku with a strong connection to the 'āina and people of the district he seeks to represent. He is a respected educator, cultural practitioner, and community leader, he is committed to preserving Hawaiian culture and values. Mr. Ako has held roles as an educator at Kamehameha Schools, President of the Hawaiian Historical Society, and Pelekikena of Kuini Pi'olani Hawaiian Civic Club.

Mr. Ako has been an advocate for the iwi kūpuna and worked to register and protect burials in Pila'a ahupua'a. With expertise in Hawaiian language, hula, and ho'oponopono, he approaches this kuleana with

sincerity and commitment. His experience, advocacy, and cultural dedication make him exceptionally qualified for this role.

Senate confirmation will ensure that Mr. Ako's knowledge and unique lived perspective informs the deliberations of the O'ahu Island Burial Council until June 30, 2029.
