My involvement in East Hawai'i, along with my experiences in other rural areas, has deepened my understanding of the significant challenges we face regarding both access to and the quality of healthcare available to our communities. For six years, I served on the board of Community First, a non-profit organization dedicated to uniting medical and social service providers in a concerted effort to enhance community health outcomes.

During my term of service at the Hawai'i Health Systems Corporation (HHSC), my primary goal is to complete a revised strategic plan that clearly defines the role of HHSC both internally and within the regions it serves. This plan will focus on establishing a cohesive direction that aligns our operations with the evolving needs of our communities.

I aim to ensure that our strategies are relevant, viable, and sustainable, enabling us to effectively carry out our directives and deliver high-quality healthcare services. By engaging with stakeholders and incorporating their insights, I hope to create a framework that not only strengthens our operational effectiveness but also enhances our responsiveness to the unique challenges faced by the populations we serve. Ultimately, my objective is to position HHSC as a leader in healthcare delivery that is well-equipped to meet the present and future needs of our communities throughout Hawai'i.
