In consideration of **GOVERNOR'S MESSAGE 701** SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE KANE OHE BAY REGIONAL COUNCIL, GUBERNATORIAL NOMINEE, FREDERICK REPPUN, FOR A **TERM TO EXPIRE 6-30-2027**

The Department of Land and Natural Resources (Department) supports Governor's Message 701 nominating Mr. Frederick Reppun to the Kāne'ohe Bay Regional Council for a term to expire on June 30, 2027.

Pursuant to Section 200D-2, Hawaii Revised Statutes, the Kane'ohe Bay Regional Council was established to, among other things, facilitate the implementation of the Kāne'ohe Bay Master Plan as it relates to ocean use activities and advise and make recommendations to the State and the County on matters regarding the use of Kane'ohe Bay by the general public, marine research programs, and commercial ocean use activities, including legislative matters. Membership on the Council includes government officials, area neighborhood board members, and individuals representing user groups of the Bay.

Mr. Reppun is currently the Education Coordinator with the He'eia National Estuarine Research Reserve. He brings with him a background in Environmental Science, as well as a deep understanding of ahupua'a connectivity. The Department welcomes the wealth of knowledge and wisdom that Mr. Reppun will bring to the Kāne'ohe Bay Regional Council.

GM 701 – SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE KANEOHE BAY REGIONAL COUNCIL, GUBERNATORIAL NOMINEE, FREDERICK REPPUN, FOR A TERM TO EXPIRE 06-30-2027.

Chair Inouye, Vice Chair Elefante, and Members of the Committee:

The Hawai'i Institute of Marine Biology (HIMB) **supports the confirmation of Fred Reppun**, a faculty member currently serving as HIMB's representative on the Kāne'ohe Bay Regional Council (KBRC). HIMB values its representation on the KBRC as required by HRS 200D-2 and is grateful that Mr. Reppun holds this position.

For the past four years, Mr. Reppun has worked at the interface of science, community, and policy, supporting the needs of both the KBRC and HIMB. Most recently, he successfully acquired funding from the Hawai'i Community Foundation to support reconvening working groups to renew the Kāne'ohe Bay Master Plan. KBRC passed a resolution to contract a planner with these funds, and the Council is in the process of forming a temporary committee.

Mr. Reppun also communicates with HIMB researchers the needs and requests for science to inform management issues that come before the KBRC and shares research findings from HIMB that are relevant to the wise use of Kāne'ohe Bay by the public, researchers, and commercial operators. Ongoing research at HIMB relevant to the planning and management of Kāne'ohe Bay includes performance and movement of herbivorous fish in response to water quality, movement and connectivity of papio in and out of Kāne'ohe Bay, coral recovery from thermal stress, impacts of kalo lo'i management on Kāne'ohe Bay water quality, effects of wastewater contaminants on coral health, and relationships between the health of coastal ecosystems and the human communities that depend on them.

For these reasons, HIMB supports the confirmation of Fred Reppun.
