Honorable Stanley Chang, Chair, and Troy Hashimoto, Vice-Chair, and members of the committee.

I wholeheartedly support the Governor's nomination of Grant Chun to the Hawai'i Housing Finance and Development Corporation board.

Grant is simply one of the best persons who can assist this important agency in addressing one of the continuing challenges of providing more housing for our people. While he is now officially retired, he is the kind of guy who will put in the time and energy that is needed to fulfill HHFDC's mission.

I admit knowing (and admiring) Grant for almost half a century. We attended Maui High School together (when the Kahului campus could truly be characterized as the "new" Maui High School—the school gym didn't open until his senior year, my junior year) where Grant was a much renowned student body and class leader (in one of the best classes that Maui High has had where students attended prestigious colleges like UC Berkeley, Pomona, Harvard, Yale, and even the University of Southern California like Grant) and one of the smart speech and debate, key club kids. He had a reputation as someone organized, friendly and reliable. He deservedly was named to the Maui High School Hall of Fame in 2016.

We attended law school in the Bay Area in the late-1980s. After Hastings, Grant returned to Maui right away to practice. When I moved home in the early 1990s we worked together in the Wailuku office of a prominent local law firm.

He served ably as Managing Director in the administration of Maui County Mayor Kimo Apana. After his county service, Alexander & Baldwin hired Grant to help manage its Valley Isle land holdings and developments, working through land use, zoning and community issues often as the local face of the company. He ended his private working life as head of Hale Mahaolu, the prime developer and manager of our island's senior independent living complexes.

Throughout his working life, Grant earned a reputation as honest, dedicated and civil and someone who treated people with courtesy and respect. People naturally wanted someone like Grant—with his knowledge, experience and passion – on their boards and committees. In his life, Grant has served on almost every board and committee that touches on some aspect and issue that makes Maui No Ka Oi and one of the best places to live, work and raise our families—

the hospital foundation board, Hawaii Health Systems Corporation, Maui Economic Development Board, Maui County Fair, appointed State Board of Education, Central Maui's Family YMCA, Legal Aid Society, various bar committees, Boy Scouts (Maui Council), Maui Economic Opportunity are among the boards who have been fortunate to have Grant serve. So Health, Education, Social and Community welfare are all areas where Grant has contributed – not just a figure head board member but as someone who participates and takes action.
