All three curriculums focused on student engagement and high expectations for student performance using active thinking and problem solving through rigorous instruction, flexible learning procedures, and classroom discussions that showcased students' understanding and fluency. To execute these rigorous curriculums, Ms. Lee offered and funded teachers' relevant professional development opportunities, in-service training sessions, and educational technology. She also hired highly qualified academic coaches to provide the right support and partner with classroom teachers in identifying goals and best practices in the classroom.

Second, Ms. Lee had strong administrative skills for managing budgets, resources, hiring, and maintaining facilities. During her time as principal, she provided resources, materials, and support for classroom management. We teachers had what we needed and wanted in our classrooms. Our students had school supplies and technology. We always had a healthy amount of copy paper and working copying machines. She invested in books. Students had guided reading and independent reading books, while teachers had professional resources to help them. We had a 16-18 to 1 student/teacher ratio in the classroom. Educational Assistants and tutors were always available to support students and teachers. Our school facility was clean, organized, and well maintained.

Third, Ms. Lee established an open-door policy and encouraged active listening. She kept lines of communication open for all stakeholders (teachers, students, parents) to voice their concerns, ideas, suggestions, and observations. As a result she addressed difficulties proactively and collaborated with stakeholders to identify and implement solutions.

In conclusion, it is for these reasons that I highly recommend Ms. Lee for the Hawaii County seat on the Board of Education. Thank you for your time and consideration.
