The Office of Wellness and Resilience (OWR) in the Governor's Office **STRONGLY SUPPORTS** H.B.1081, Relating to the Office of Wellness and Resilience. H.B.1081 proposes to transfer the OWR to Department of Human Resources Development (DHRD) on June 29, 2025, representing a strategic alignment that would enhance both OWR and DHRD's effectiveness.

Governor Josh Green, M.D.'s February 2024 Executive Order reinforcing Hawaii's commitment to becoming a trauma-informed state makes this recommended transfer particularly timely. DHRD's established cross-departmental infrastructure provides the ideal platform for implementing trauma-informed practices throughout state government. Review of Departmental priorities demonstrates significantly stronger operational synergies with DHRD, particularly regarding workforce development and wellness initiatives.

Data from the recent Hawai'i Quality of Life and Well-Being Dashboard reveals a need to enhance employee recruitment and retention and workplace wellness across state departments. Housing OWR within DHRD will enable more efficient, widespread implementation of such initiatives (e.g., training opportunities, supervisor supports and workforce wellness) and regularly cadenced assessment through existing administrative channels.

Finally, this transfer optimizes state resources without compromising OWR's core functions. The Office will maintain its vital community partnerships, listening and feedback sessions, and program enhancement initiatives--essential elements of our work to date. These community connections remain critical for understanding the needs in the community, how they might impact policies for both state employees and the broader public we serve and continue to create relationships to partner and enhance the State's work.

The proposed transfer represents both a strategic alignment and fiscally responsible approach to expanding OWR's positive impact on state operations. We are grateful for the Committee's support on ensuring OWR can fulfill its mission on making Hawai'i a trauma-informed state.

Chair Marten, Vice Chair Olds, and Members of the Committee:

The Department of Corrections and Rehabilitation (DCR) strongly supports
House Bill (HB) 1081, which proposes to transfer the Office of Wellness and Resilience
(OWR) to the Department of Human Resources Development (DHRD) on June 29,
2025. The measure also creates a wellness and resilience advisory board and updates
the Office of Wellness and Resilience functions.

On February 20, 2024, the Governor signed Executive Order 24-01 declaring Hawai`i as a trauma-informed state. The purpose of this executive order is to require all state departments to collaborate and partner with the OWR to integrate trauma-informed care principles, such as safety, transparency and peer support, into our workplaces and services.

Through these partnerships, OWR strives to strengthen state systems through the implementation of trauma-informed principles across agencies through organizational assessments, training, and other trauma-informed care efforts. OWR's mission strategically aligns with DHRD's cross-departmental infrastructure on workforce development and improvement of recruitment and retention of state employees.

The DCR appreciates the on-going partnership with OWR to implement a pilot program to train employees in trauma-informed principles. I support HB 1081 Relating to the Office of Wellness and Resilience (OWR). The bill proposes to transfer the Office of Wellness ad Resilience from the Governor's Office to the Department of Human Resources and Development. The bill also authorizes OWR to carry out Trauma Informed training for other state departments.

In 2023 the Mālama 'Ohana Working Group was established to develop recommendations to establish a child welfare system that is trauma-informed, sustains a community-based partnership, and responds to the needs of children and families in the system and the community. I serve as Co-Chair of the working group. The report emphasizes that Hawai'i's child welfare system is fragmented, with agencies working in silos rather than in a coordinated and unified way. This lack of collaboration creates inefficiencies, weakens oversight, and ultimately harms children and families. Our Working Group was established under the administration of OWR, which allowed us to depend upon the incredible expertise and the ability to work across the system. Our working group did not receive state funding, but with OWR support and private partnership with the Hawai'i Community Foundation, Kamehameha Schools, Annie E. Casey Foundation, and Casey Family Programs, we were able to carry out our duties. This could not have been accomplished if the working group had been administratively embedded in the Department of Human Services.

The working group has completed its work and a full copy of the report can be found at <a href="https://www.malamaohana.net">www.malamaohana.net</a>, however the working group is still subject to sunshine law until adjournment sine die. To be clear, the working group will not be making further decisions now that the report has been filed. The working group may meet during the session to provide information to the public about its report but will not make further decisions. Therefore, it is not allowed under sunshine law that more than two of us meet to discuss the report, or next steps. Therefore, I am testifying as a concerned citizen and speaking for the content of the report that was approved by the working group.

Our first task as the Mālama 'Ohana Working Group was to establish an approach to our work by cultivating and modeling the kind of listening and concern that we needed for our working group and modeling the type of child welfare system we hope for. From there, we began with the intense work of interviewing individuals, conducting

conversations, and holding group discussions in Permitted Interaction Groups, which helped shape our initial understanding. We then conducted eleven community listening sessions throughout the state, gathering stories and ideas from each community we visited. OWR was the ideal administrator for our work, and at each step of the way we realized the importance of that alignment. Our working group had its first meeting right after the Maui fires. OWR was called upon to immediately attend to the crisis. Their work at that time, like our work in the Mālama 'Ohana Working Group illustrates how vital cross-system coordination is to our state.

#### What we heard:

- 1. No Single Agency Can Address Child Welfare Alone The system involves Child Welfare Services (CWS), family courts, the Department of the Attorney General, law enforcement, health agencies, schools, and community service providers. However, these entities often operate independently instead of collaboratively.
- 2. Families Struggle to Navigate Bureaucracy Because agencies do not always share information or work together, families face barriers in accessing services like housing assistance, mental health support, and substance abuse treatment.
- 3. Gaps in Services Due to Lack of Coordination Many families fall through the cracks because agencies do not communicate effectively, resulting in delays, duplicative efforts, and missed opportunities for intervention.
- 4. Inconsistent Policies Across Agencies Policies governing child protection, legal processes, and social services are not always aligned, leading to contradictory approaches and confusion for families and service providers.
- 5. Need for a Shared Vision The report stresses the importance of a unified, trauma-informed, culturally responsive approach that brings all agencies together to prioritize child and family well-being.

It is the kuleana of OWR to strengthen our state systems, and to ground all our collective work in the values and principles necessary to create a trauma-informed Hawai'i. This kuleana represents our best hope for a healthy and prosperous state in a time of turmoil and challenges. OWR must have the agility and the support it needs to lead this important mission. We understand that an office like OWR cannot remain administratively connected to the Governor's office indefinitely. It would be ideal to have OWR remain with the Governor for another year or two, but if a move is necessary then the Department of Human Resources Development is a more appropriate place because of its established cross-departmental infrastructure provides the ideal platform for implementing trauma-informed practices throughout state government. This bill represents a strategic alignment that would enhance both OWR and DHRD's effectiveness.

We are grateful for your support of the families and children in the child welfare system, and your efforts to find ways to improve the system.
