This bill represents a critical investment in public safety by establishing and maintaining the Automated Speed Enforcement Systems Program, which aims to reduce speed-related motor vehicle fatalities and injuries on our state highways. ### HB 1166 RELATING TO AUTOMATED SPEED ENFORCEMENT SYSTEMS PROGRAM.

Dear Chair Kila, Vice Chair Grandinetti, and Committee Members,

The Oahu Metropolitan Planning Organization (OahuMPO) supports HB 1166 which would appropriate funds out of the State Highway Fund for the Automated Speed Enforcement Systems Program Special Fund and would appropriate funds out of the Automated Speed Enforcement Systems Program Special Fund for fiscal year 2025-2026.

This bill supports the goal of reducing traffic related deaths and serious injuries to zero by 2045. Traffic fatalities increased ten percent between 2023 and 2024 in Hawaii. In 2024, the State of Hawaii Department of Transportation conducted an annual behavioral study, and nearly one-quarter of respondents admitted to exceeding the speed limit by more than 20 miles per hour, and over half exceeded the speed limit by 10-20 miles per hour in the last six months. Appropriating additional funds would enable the maintenance of the current Automated Speed Enforcement System and expansion of the system to other locations.

The OahuMPO is the federally designated Metropolitan Planning Organization (MPO) on the island of Oahu responsible for carrying out a multimodal transportation planning process, including the development of a long-range (25-year horizon) metropolitan transportation plan, referred to as the Oahu Regional Transportation Plan (ORTP), which encourages and promotes a safe, efficient, and resilient transportation system that serves the mobility needs of all people and freight (including walkways, bicycles, and transit), fosters economic growth and development, while minimizing fuel consumption and air pollution (23 CFR 450.300).
