Chair Yamashita, Vice Chair Takenouchi and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 1237, HD1 relating to biosecurity, which appropriates funds to the Department of Agriculture (Department) for agricultural biosecurity and the prevention, detection, and control of invasive species in Maui County.

The Department supports this measure and offers comments. The Department recognizes that Molokai and Lanai have historically not had dedicated Plant Quarantine Branch (PQB) staff, which this measure seeks to rectify. As both islands currently do not have dedicated import or interisland movement volumes, it is suggested that instead of dedicated PQB inspectors, perhaps the use of a number of general professional series workers, a position that could perform other inspections and duties on Molokai and Lanai for the Department, may be the best way to alleviate this issue.

To attempt to bridge the gap in staffing, the Department currently has Mauibased inspectors go to Molokai on a routine basis. Additionally, the Maui staff work closely with the Molokai Invasive Species Committee and Pu Lama Lanai as issues



arise and the Department is appreciative of the important work they do on Molokai and Lanai.

The Department is supportive of any effort that provides additional resources to manage pests throughout the State. While the Department is in support of this measure for Maui County, the Department believes that each county should also have additional resources for coqui control.

Thank you for the opportunity to testify on this measure.

House Bill 1237 House Draft 1 appropriates funds to the Department of Agriculture (HDOA) for agricultural biosecurity and the prevention, detection, and control of invasive in Maui County. **The Hawai'i Invasive Species Council (Council) supports this measure.** 

HDOA is the only agency with regulatory authorities to inspect, quarantine, and carry out activities to prevent the introduction and spread of invasive species. The establishment of positions to serve Molokai and Lanai will help to improve biosecurity. Both islands have been able to prevent the introduction and establishment of CRB, little fire ants, and coqui frogs through the efforts of the Island Invasive Species Committees and the Pulama Lanai Natural Resource Program.

Invasive species committees are our first line of defense against these threats. These volunteerbased, community-focused organizations are on the ground every day, actively monitoring, detecting, and removing invasive species. The establishment of a Lanai Invasive Species Subcommittee seems like a natural step to ensuring the island is safegaurded from new pests.

This measure is an important step to improving biosecurity for Maui County and recognizes that biosecurity cannot be done by one agency alone. It is also important that this funding is recurring to support the efforts established in this measure and do not lapse.

Aloha Chair Yamashita, Vice-Chair Takenouchi, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports HB 1237, HD1, which appropriates funds to the Department of Agriculture for agricultural biosecurity and the prevention, detection, and control of invasive species in Maui County. Strengthening biosecurity efforts in Maui County is critical to protecting local agriculture, ecosystems, and rural communities from the devastating impacts of invasive pests.

Moloka i and Lāna i currently lack a dedicated state agricultural inspector and quarantine facility, leaving these islands vulnerable to the introduction and spread of invasive species. Without early detection and rapid response measures in place, high-risk pathways such as the importation of plants, mulch, used vehicles, and farm equipment increase the likelihood of invasive pests establishing themselves. To date, pests such as the little fire ant, coconut rhinoceros beetle, and coqui frog have not been detected on Moloka i or Lāna i, making prevention efforts all the more urgent.

This measure provides funding for general biosecurity professionals for Moloka'i and Lāna'i to monitor cargo entering these islands. It also establishes a Lāna'i Invasive Species Committee as a sub-branch of the Maui Invasive Species Committee, ensuring that local resources are dedicated to invasive species prevention and response. Additionally, HB 1237, HD1 allocates resources to combat the growing threats of little fire ants, coconut rhinoceros beetles, and coqui frogs on Maui, where invasive species management efforts require sustained funding to protect agriculture, the environment, and local communities.

Hawai'i's biosecurity challenges are increasing due to rising global trade and tourism, climate change, and gaps in prevention infrastructure. The cost of controlling invasive species after they become established is significantly higher than the cost of prevention and early intervention. Protecting Moloka'i and Lāna'i from these threats will not only safeguard local agriculture but also preserve these islands as repositories for native species and agricultural biodiversity.

We urge the committee to pass HB 1237, HD1 to enhance agricultural biosecurity in Maui County and protect Hawai i's farmers, ranchers, and natural resources from the ongoing threat of invasive species.

# Testimony on HB 1237, Relating to Biosecurity

Aloha Chair Yamashita, Vice Chair Takenouchi, and Members of the Committee on Finance,

Thank you for this opportunity to testify on HB 1237 HD1, *Relating to Biosecurity*, which proposes to allocate funding for biosecurity and invasive species management in Maui County. Mahalo for the increased emphasis on invasive species. The Maui Invasive Species Committee (MISC) supports this measure and offers the following comments.

# Section 2

Little Fire Ants: Section 2 of the bill proposes to appropriate funds for the department of agriculture "to prevent and control little fire ant and coconut rhinoceros beetle infestations in Maui county, including through the hiring of general professionals for biosecurity efforts." The initial version of the bill proposed to establish full time inspector positions on both Molokai and Lāna'i. The Department of Agriculture offered testimony explaining that the volume of agricultural commodities arriving on these two islands did not warrant full-time positions and that, in the past, both inspection and response operations for these islands had been performed by a single individual in a hybrid-type position. Based on discussions during the hearing before the Committee on Agriculture and Food Systems, the language was changed to "hiring of general professionals". MISC supports increased capacity for agricultural inspection for Molokai and Lāna'i, and for response and control for little fire ants (LFA) and coconut rhinoceros beetle (CRB), but remains concerned that if the legislature intends to increase resources for control of little fire ants, the language is not clear as to who will do the work.

Maui is at a critical point for LFA control—in the last 14 months, eight new infestations were discovered, from Kīpahulu to Napili. Eradication takes time, staff, equipment and expertise. With the exception of extremely small infestations, comprehensive ground surveys are needed to determine the extent of the infestation, followed by 6 to 22 treatments, and surveys for another five years after no ants are detected. MISC is actively treating infestations at 13 different locations and has been the lead entity for control and monitoring at most of the 28 infestations discovered to date. These populations involve 120 properties; each one requires ongoing communication during

delimitation, treatment and monitoring phases. MISC has nine staff focused on LFA; staffing should double to keep up with current locations, and one team should be based in Hāna to address East side locations. A review of efforts to date predicts that eradication of all known sites will at least \$5 million. Funding from the County of Maui and Hawai'i Invasive Species Council are providing essential support, but will not be enough to meet current needs. This work depends on ongoing collaboration with the Hawai'i Department of Agriculture and Hawai'i Ant Lab.

**Coconut rhinoceros beetle:** Section 2 does not specify who will conduct early detection work for CRB in Maui County. Both MISC and the Molokai Invasive Species Committee (MoMISC) are conducting early detection surveys in coordination with Maui County Department of Agriculture and the University of Hawai'i CRB Response team.

## Section 3

**Coqui Frogs:** Section 3 proposes to allocate funding to MISC, as a project of the University of Hawai'i Pacific Cooperative Studies Unit, to combat the spread of coqui frogs in Maui County. To date, MISC has eradicated nearly 30 breeding populations, suppressed coqui in portions of Ha'ikū, and continues to respond to outlier coqui frogs that pop up across the island. MISC manages a community control program that is helping residents take back their quiet nights. Much work remains to be done. MISC supports the opportunity to expand on this vital work with the proposed allocation.

**Lāna'i Subcommittee:** MISC previously conducted invasive species survey and control operations on Lāna'i and would be pleased to collaborate with Pūlama Lāna'i and the broader Lāna'i community to establish a Lāna'i subcommittee.

The three invasive species that are the focus of HB 1237 are also the subject of a signed Memorandum of Agreement among the Department of Agriculture, Department of Land and Natural Resources, and University of Hawai'i. The MoU identifies roles and responsibilities for each County. MISC and MoMISC remain committed to working closely with our partners on invasive species threats to native biodiversity, live-giving waters, local agriculture, and quality of life, and appreciate the intent of this bill to help all partner agencies achieve our common goals.

## **Testimony in Support of HB1237 HD1**

Aloha Chair Yamashita, Vice Chair Takenouchi, and Members of the Committee,

The Coordinating Group on Alien Pest Species (CGAPS) is **in support of HB1237 HD1**, *Relating to Biosecurity*. This bill provides appropriations: (1) to the Hawaii Department of Agriculture (HDOA) to prevent and control little fire ant (LFA) and coconut rhinoceros beetle (CRB) in Maui county, including through the hiring of general professionals for biosecurity efforts; (2) to the University of Hawaii Pacific Cooperative Studies Unit (UH-PCSU) for the Maui Invasive Species Committee (MISC) or its Molokai subcommittee (MoMISC) to support education, early detection, response, and control efforts regarding coqui frogs, including by establishing a Lanai Invasive Species Committee as a sub-branch of MISC. HB1237 HD1 also authorizes HDOA to make grants to or enter into contracts with UH-PCSU for MISC or MoMISC.

Since its formation in 2001, MoMISC has effectively provided on-island capacity for pest detection and rapid response and MoMISC is honored to continue this work. However, the on-island presence of an HDOA official is necessary to conduct the official duties of HDOA. On Lanai, partnership work with Pūlama Lāna'i has been critical for pest detection and rapid response, but they cannot fulfill the regulatory duties of HDOA.

We hope that any Invasive Species Committee established for Lanai is able to address all highimpact invasive species and is not limited to coqui frog.

Mahalo for the opportunity to support the bill and for consideration of our testimony.

My name is Benton Pang, and I strongly support SB1100 to strengthen biosecurity efforts in Hawai'i. Invasive species like coqui frogs, little fire ants (LFA), and coconut rhinoceros beetles (CRB) threaten our ecosystems, agriculture, and communities.

Maui has had 28 LFA incursions, with eight new sites in the past 14 months. MISC has led containment efforts but needs more resources to prevent further spread. CRB also poses a growing risk, requiring increased inspection and response capacity. This bill also supports coqui frog control and establishes a Lāna'i Invasive Species Subcommittee to improve response efforts.

However, the current language does not explicitly fund MISC and MoMISC for LFA and CRB. These organizations are critical in containment and should receive direct support. Maui County has led the way in invasive species management, and this bill would provide much-needed State resources.

I live in Haiku, Maui and am a farmer on my 1/2 acre property that borders the Eastern Maui Irrigation reservoir that is contiguous with Maliko Gulch. I have personally experienced the every increasing impact of coqui frog - SO LOUD and in such great volumes now that I need to shut my windows and doors in the evening as the sound is deafening.

With the decimation of the MISC Coqui Crew, I have tried to manage the coqui on my own but it is a LOSING BATTLE!

When MISC was fully staffed, I was grateful that the MISC tanker truck and response team was able to access both my property and the EMI Reservoir to spray - their work successfully held the coqui somewhat at bay but now, without a response team, the coqui are OUT OF CONTROL!

MISC also kept a sound meter on the edge of my property to monitor the coqui population; sadly, with their limited resources, they needed to remove the sound meter and use it elsewhere for a bird project. Clearly, more sound meters are critical to monitor the coqui frog population, collect data, and ensure that resources can be effectively targeted.

BOTH the Coqui Crew and the monitoring resources are no longer available and MUST BE RESTORED AND EXPANDED!

NOW is our opportunity to squelch the coqui AND address CRB before they rise to the level of invasion that coqui have on our beautiful Maui.

PLEASE support any and all resources to stop these threats to our environment.

In addition to multiple tree crops, I also harvest and sell coconut. Without the ESSENTIAL BIOSECURITY SUPPORT. our island is doomed to go the way of the Big Island re: coqui and ALL of Hawaii Nei is in jeopardy if the CRB are not eradicated.

Aloha- I live on Kaluanui Road next to Maliko Gulch which was ground zero for the coqui invasion on Maui. **I now sleep with a pillow over my head because the frogs are SO loud.** MISC has been instrumental in helping us to push the frogs back but they are severly understaffed and often can only offer free citric acid to us so we can do the spraying ourselves. I work fulltime and my husband is disabled and I am often just too tired to spray at night. I have to suit up, mix up the potion. drag the sprayer around the yard, and hope that I can get at least some of the frogs. It needs to be done weekly just to keep them away from our windows. I even hand catch them and freeze them to their death. The whole invasion has really impacted our sleep as well as our enjoyment of our property after dark! We can't sit on our lanai because we can't hear each other talk unless we yell!

*MISC really needs more funding.* Their's is a thankless job and they have many shifts after dark. We totally appreciate their efforts but it is not enough to combat this invasive species. **Once you, yourself, have them on your property, you will understand what a nuisance they are.** Just listen to any live news broadcast from the Big Island and you will hear and then understand the breadth of the problem! I am sure our property value has suffered because of the noise.

# Please FUND MISC. This bill isn't perfect but the main thing is that you give MORE money to MISC for coqui and fire ant eradication.

My name is Lauren Lipcon and I own 2 acres of AG land in Maliko Gulch. We are converting a neglected coffee farm into a fruit forest and are also working towards farming hawaiian tropicals for luxe XL arrangements.

We are basically at Cocqui ground zero. When I purchased 2 years ago, MISC was providing excellent support with regular sprayings. We had the frogs pushed so far back that they were close to gone. Then suddenly MISC stopped coming. They told me they lose their funding. All of the work that was previously done was lost. The frogs have inundated our property and farm and are destroying our eco system, plus simple but necessary things like sleeping are challenging. Also renting our ohana to a long term tenant is also challenging in part due to the frogs. Not to mention the threat to property value.

MISC services are CRITICAL to protect our eco system, whether it be the frogs, ants or coconut rhinocerous. We have over 150 rare palms on the property and if the beetle were to take them out it would be devastating.

Please give MISC the funding they need to protect our delicate paradise. They need funding, and our environment needs to be #1. We only have one Maui. Let's protect it.

I am a long-time resident of Wailuku, Maui, and a long-time supporter of the important work of the Maui Invasive Species Committee. I SUPPORT HB1237 to provide funding for MISC and the creation of the Lanai Invasive Species Committee.

Maui has had 28 incursions of little fire ants. MISC has been the lead entity for delimitation, treatment, and monitoring for more 90% of those sites. In the last 14 months, eight new locations were discovered. MISC needs more resources to prevent little fire ants from becoming unstoppable. Maui has suffered enough over the past few years, thank you very much, we do not need to add little fire ants to our issues!

The County of Maui has been a leader among the other Counties in supporting work on invasive species, including on little fire ants and coqui frogs. This bill would provide necessary State resources to support that work.
