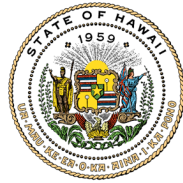

Chairs Gabbard and Chang, Vice Chairs Richards and Hashimoto and Members of the Committees:

Thank you for the opportunity to provide testimony on House Bill No. 1294, House Draft 2 that establishes within the Department of Agriculture (Department) a 29-member Agricultural Workforce Housing Working Group to address the "shortage and challenges of agricultural workforce housing in the State". The Department is to provide administrative support and co-chair the Task Force with the Agribusiness Development Corporation. The bill requires an interim report to the Legislature prior to the 2027 session and the final report by the 2028 session. There are two separate appropriations for FYs 25-26 and 26-27 to gather the necessary data and prepare the required report, including any consultation fees and related expenses. The Department appreciates this measure's intent and offers **comments**.

The Department recommends that an early task of the Task Force, once established, is to gather data and information and survey farm operators to assess the realistic demand for farm workers. This information would inform a targeted rather than broad assessment of agricultural workforce housing needs. For instance, in 2022, 59 percent of Hawaii's 6,569 farms (federal definition) made less than \$10,000 a year in revenue from agricultural product sales. We do not know if these lower-income farm operations are able to hire farm workers, much less afford building and operating on-farm worker housing or be able to participate in alternative worker housing. A possible solution may be congregate living facilities located in the vicinity of where these small farm operations are aggregated.

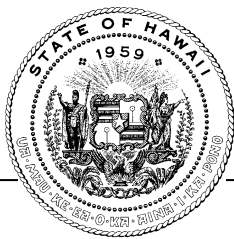



Aloha Chairs Gabbard and Chang, Vice Chairs Richards and Hashimoto, and Members of the Committees:

The Department of Hawaiian Home Lands (DHHL) **supports** this bill which 1) establishes an Agricultural Workforce Housing Working Group within the Department of Agriculture to address the shortage and challenges of agricultural workforce housing in the State, 2) requires reports to the Legislature, and 3) appropriates funds.


The Hawaiian Homes Commission Act, 1920, as amended, authorizes DHHL to lease agricultural lands or lands used for aquaculture purposes. DHHL has awarded 1,105 agricultural leases as of December 31, 2024 – 60 on Oahu, 64 on Maui, 406 in East Hawaii, 111 in West Hawaii, 46 on Kauai, and 418 on Molokai. DHHL also has 19,939 applications for an agricultural lease as of January 1, 2025 – 4,220 on Oahu, 4,840 on Maui, 7,410 on Hawaii Island, 2,327 on Kauai, and 1,142 on Molokai.

DHHL's General Plan Update dated November 2022 notes the following: "The connection to 'āina and ability to cultivate it and bring forth life is central to Prince Kūhiō's vision for the rehabilitation of Hawaiians. The first homestead pilot program focused on agriculture production as evidence that the Hawaiian Homesteads work. Today, agricultural homestead lots have the longest waitlists on all islands except for O'ahu." The Plan also provides that "the majority of agricultural applicants who responded (80%) indicated that they intend to farm and live (i.e., build a home) on their agricultural lot when awarded. The agricultural activities that applicants anticipated for their lots, once awarded, were mostly subsistence and gardening activities, while 11% of waitlist respondents anticipated using their agriculture lot for commercial farming." The Plan further explains that "DHHL is developing an Agriculture Program Plan to increase beneficiary capacity in farming. Programs will range from training in beginning farming to more advanced programs for commercial agriculture."

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports HB 1294, HD2, which requires the Department of Agriculture to establish an Agricultural Workforce Housing Working Group to address the shortage and challenges of agricultural workforce housing in the State.

HFB recognizes the need for agricultural workforce housing and believes that affordable housing is necessary to attract farm workers. This has been a major shortfall as we try to address the labor needs for agriculture and is a limiting factor for the growth of agriculture in Hawai'i.

The shortage of willing and able workers, the need for affordable housing for farm workers, and competition from alternative employment are several of the pressing farm-labor-related issues that need to be addressed.

The lack of affordable housing for farmers and farm labor impedes increasing food and non-food agricultural production in Hawai'i. There is a need to develop housing for farmers and farm employees while ensuring that the housing is used in conjunction with an active farm and occupied by bona fide farmers and farm employees.

An Agricultural Workforce Housing Working Group can help identify the agricultural workforce housing needs in each County and help identify the barriers to meeting the housing needs for farm and ranch businesses in Hawai'i.

The Office of Hawaiian Affairs (OHA) submits this testimony in support of **HB1294 HD2** that works toward addressing the pressing issue of agricultural workforce housing in the state. The bill proposes the establishment of an Agricultural Workforce Housing Working Group within the Department of Agriculture, tasked with identifying solutions to housing shortage and affordability for agricultural workers.

OHA appreciates that this measure will help to address the needs of stability and productivity of Hawai'i's agricultural industry. The provisions of the bill include the consideration of financial incentives, such as tax credit programs for agricultural employers who invest in housing solutions for their workforce. Additionally, the working group will study the feasibility of implementing a state income tax credit for investors who incur costs related to the construction, installation, acquisition, or rehabilitation of agricultural workforce housing. These provisions allow for

OHA recognizes that the bill promotes local agricultural and labor shortages in agriculture. For that reason, recommendations to build agricultural housing stock must emphasize its affordability with the goal of attracting skilled and stable farm workers and increasing farm income. Providing worker housing may not be considered a taxable benefit, so this enables the farmworker or ranch hand to receive a lower taxable wage rate because workers housing costs are available at a low- or no-cost, and workers commuting costs may be reduced or eliminated.

This measure is in alignment with The Office of Hawaiian Affairs (OHA) mission to improve the conditions of Native Hawaiians and ensure their equitable access to housing, aina mamona, and economic opportunities. It reflects our commitment to advancing the well-being of our beneficiaries and the broader community. This measure will help to

improve living conditions for agricultural workers and increase food security and sustainability for Hawaii.

OHA urges the Committees to **PASS HB1294 HD2** establishing a working group to support agriculture and affordable housing . Mahalo nui.

The Hawai'i Farmers Union is a 501(c)(5) agricultural advocacy nonprofit representing a network of over 2,500 family farmers and their supporters across the Hawaiian Islands. **HFU strongly supports HB1294.**

HB1294 proposes the formation of an Agricultural Workforce Housing Working Group within the Hawaii Department of Agriculture to tackle the persistent shortage of farmworker housing. Providing affordable and adequate housing is essential for the stability and productivity of Hawaii's agricultural sector. By assessing current policies, identifying housing needs, and exploring partnerships, the working group can develop targeted solutions to improve workforce retention and support farm operations.

A key focus of the working group should be exploring innovative housing models, including cooperative housing and on-farm housing solutions tailored for seasonal workers. Proposed policy changes must balance housing needs with the preservation of agricultural lands to sustain long-term food production. Financial incentives, such as tax credits and subsidies, should be structured to provide benefits to farms of various sizes, ensuring equitable access to resources for improving workforce housing. Expanding access to financing tools will further support farmers in implementing sustainable housing solutions that meet both regulatory and operational needs.

To ensure accountability and long-term impact, HB1294 requires the working group to submit interim and final reports to the Legislature. With a strong commitment to sustainability, inclusivity, and practical feasibility, this initiative has the potential to address a critical challenge for Hawaii's agricultural workforce and contribute to a more resilient local food system.

As seen in the amendments in HD 2 the establishment of the Agricultural Workforce Housing Working Group within the Department of Agriculture will provide a structured approach to addressing the housing needs of agricultural workers.

Aloha e nā Luna o ka Hale o nā Lunamaka‘āinana,

I am Tiare Smith, a Native Hawaiian resident of Kahalu‘u, O‘ahu, where I have resided for 45 years, tethered to this ‘āina through ancestry, stewardship, and a deep-seated commitment to its vitality. It is with both urgency and optimism that I submit this testimony in resolute support of House Bill 1294, an Act Relating to Agricultural Workforce Housing. This bill confronts a crisis that has long festered beneath the surface of Hawaii’s agrarian economy: the acute shortage of housing for our agricultural workers, a predicament that undermines the very foundation of our food security and cultural heritage.

For decades, I have observed the precipitous erosion of affordable living options for those who toil on our lands—workers whose labor ensures that kalo, ‘ulu, and other staples of our sustenance endure. The absence of proximate, dignified housing has disenfranchised these essential contributors, forcing many into untenable commutes or precarious living conditions that belie the aloha we profess as a state. HB 1294 astutely recognizes this as a systemic failing and proposes a remedy through the establishment of an Agricultural Workforce Housing Working Group within the Department of Agriculture. This initiative is not merely pragmatic; it is a moral imperative, aligning with the Hawaiian principle of mālama ‘āina—caring for the land and those who cultivate it.

The composition of the working group, co-chaired by the Chairperson of the Board of Agriculture and the Chairperson of the Agribusiness Development Corporation, with representation from state and county leaders as well as agricultural stakeholders, reflects a sophisticated, multi-faceted approach. Its mandate—to assess housing needs, evaluate existing resources, revise zoning policies, explore partnerships, and propose financial incentives—demonstrates an intellectual rigor that promises actionable outcomes. By tasking this body with identifying adaptive reuse opportunities and studying tax credits for investors, HB 1294 lays the groundwork for innovative solutions that could transform fallow government assets into vibrant communities for our agricultural workforce.

As a resident of Kahalu‘u, I am keenly aware of the spatial and economic constraints that render housing near agricultural zones a persistent challenge. The bill’s focus on revising land use policies to permit construction near these areas or within mixed-use zones is a bold step toward

reconciling human needs with ecological integrity. Such measures would not only bolster our farmers' ability to thrive but also reduce the carbon footprint of their daily lives—a synergy that is anything but antithetical to Hawaii's sustainability goals. Moreover, the appropriation of funds for fiscal years 2025-2026 and 2026-2027 ensures that this working group has the resources to fulfill its ambitious charge, delivering interim and final reports to the legislature by 2027 and 2028, respectively.

The stakes of inaction are profound. Without secure housing, our agricultural workforce—already strained by rising costs and labor shortages—faces a future of instability that threatens the resilience of our local food systems. HB 1294 offers a lifeline, a chance to honor the interdependence of our people and our 'āina. I urge the legislature to pass this bill with alacrity, appropriating the necessary funds to set this vital work in motion. To delay is to perpetuate a legacy of neglect; to act is to forge a path toward equity and abundance for all who call Hawaii home.

A week's worth of food stock is an insult to the people of Hawaii by their elected officials. Especially to the low-income citizens who already face the challenge of food insecurity on a daily basis. In order to increase the state's food reserves, Miles recommends utilizing the military, emergency management sectors, and food distributors.

30-40% of small farms are threatened because they cannot afford to comply with the demands of unfunded mandates, such as the Food Safety Modernization Act. Cabral recommends public and private investment in small farms, so that farmers can meet the strict measures and keep their homes. The State Legislature must adhere to Cabral's recommendations to provide more availability of long-term leases for farmers. With this government funded investment, they won't have to worry about the possibility of having to sell their farmland because of expensive, short term leases. Public investment in long-term leases near farmland will give small farmers peace of mind in knowing they can utilize their capital to meet the strict measures of the Food Safety Modernization Act.

If farmers aren't receiving adequate financial support from their government then they, like other industries in America, will be dominated by large corporations, looking to buy up their land. Small farms need the support of the Hawaii State Legislature. Our entire food industry depends on it.
