

## **TESTIMONY IN SUPPORT TO HOUSE BILL 1345 HD1**

RELATING TO TEACHER EDUCATION.

## House Committee on Finance Hawai'i State Capitol

Aloha Chair Yamashita, Vice-Chair Takenouchi and Members of the Finance Committee,

The Office of Hawaiian Affairs (OHA) stands in strong **Support of HB 1345 HD1**, which, as amended, would grant a tuition waiver and mandatory fee waiver to resident students enrolled in a four-year college campus of the University of Hawaii with an education program or that offers an education degree for the semester or term in which they complete their student teaching requirement. This bill reduces financial barriers to obtaining an education degree, helps to address teacher shortages, and strengthens the overall educational system. Furthermore, it fosters a more culturally responsive teaching environment, ultimately benefiting all students across Hawai'i.

Aligned with OHA's Strategic Plan Mana i Mauli Ola, this bill addresses the critical barrier of financial hardship, which often prevents Native Hawaiian students from completing education degrees. By providing financial relief during student teaching, HB 1345 HD1 encourages more Native Hawaiians and Hawai'i residents to pursue and complete teaching degrees, supporting the growth of a more diverse and qualified educator workforce. This bill is not just about financial assistance—it empowers Native Hawaiians to contribute to the education system as teachers. Increasing the number of Native Hawaiian educators leads to more culturally relevant teaching, which improves educational outcomes for Native Hawaiian students and strengthens the broader community.<sup>1</sup>

This Bill also aligns with OHA's Economic Stability goals seek to increase economic opportunities and self-sufficiency for Native Hawaiians. HB1345 HD1 contributes to those objectives by supporting a critical career path—teaching—which offers long-term, stable employment. It enables Native Hawaiian students to enter a

rewarding profession without the additional burden of tuition fees during their student teaching. By eliminating financial barriers, this bill also strengthens Hawaii's public education system and addresses the ongoing teacher shortage. Teachers are vital not only to the educational system but to the overall economic stability of communities. Furthermore, increasing the number of Native Hawaiian teachers creates a positive cycle, as students are more likely to thrive in environments that reflect their cultural identity.<sup>2</sup> This bill not only directly supports Native Hawaiian students but also enhances the educational system by integrating Native Hawaiian values, culture, and perspectives into our schools.

We urge the committee to pass **HB 1345 HD1** and thank you for your attention to this important issue for the future of Native Hawaiian students and communities.

Bill Title: HB 1345, HD1 RELATING TO TEACHER EDUCATION.

**Purpose of Bill:** Requires the Board of Regents to grant a waiver on all tuition and mandatory

fees to a resident student enrolled in a four-year college campus of the University of Hawaii System with an education program or that offers an education degree for the semester or term that the student enrolls in a State-Approved Teacher

Education Program. Effective 7/1/3000. (HD1)

### **Department's Position:**

The Hawaii State Department of Education (Department) supports HB 1345, HD1 but defers to the University of Hawaii as to its impact and implementation.

With ongoing teacher shortage issues in Hawaii and throughout the nation, the Department supports efforts to help reduce the cost of teacher preparation. HB 1345, HD1 seeks to assist in this effort by granting a waiver of tuition and mandatory fees for resident students during their semester of student teaching at a University of Hawaii educator preparation program. The student teaching component of teacher preparation is a critical milestone in a teacher candidate's journey into the education profession. Alleviating the burden of cost for this component would benefit all parties involved.

HB 1345 HD1 - RELATING TO TEACHER EDUCATION

Chair Yamashita, Vice Chair Takenouchi, and Members of the Committee:

While the University of Hawai'i (UH) supports the intent of HB 1345 HD1 and is actively working on plans to recruit additional students to become teachers, the UH has concerns with the bill as currently written. HB 1345 HD1 aims to provide tuition waivers for resident students completing their student teaching requirements in the College of Education at the University of Hawai'i at Mānoa. While this measure could be a crucial step in addressing the state's ongoing teacher shortage and ensuring that we develop a strong and sustainable pipeline of educators for Hawai'i's schools, the budgetary impacts for UH Mānoa would need to be addressed.

The successful collaboration between Kamehameha Schools and Chaminade demonstrates that when tuition assistance is offered, students are much more likely to pursue careers in teaching, thereby increasing the number of qualified educators in our state. Thus, some method of providing tuition assistance would benefit our teacher pathways. However, without a clearer method of generating revenue, there would be no way to adequately fund the College of Education.

The UH is actively working to create robust teacher education pathways and a comprehensive recruitment strategy to attract and retain future educators. While we can support the intent of this bill as it would align with these efforts and enhance the state's ability to meet its educational workforce needs, there would need to be much more discussion regarding the financial impact. If these larger budgetary issues can be resolved, then providing tuition assistance to include UH Hilo and UH West Oʻahu could be recommended as well.
