HOUSE BILL 1378 RELATING TO THE STATE FOUNDATION ON CULTURE AND THE ARTS

Dear Chair Kapela and members of the Committee,

The SFCA SUPPORTS H.B.1378 which establishes the Performing Arts Grants

Program to support performing arts in the State; Clarifies the scope of the State

Foundation on Culture and the Arts' responsibilities to include the coordination, planning,

promotion, marketing, and execution of performing arts events; Appropriates funds to

provide grants under the Performing Arts Grants Program.

The performing arts in Hawaii are a vital part of our community and currently receive SFCA support through General Fund appropriations from the legislature and Federal funding from the National Endowment for the Arts. Performing Arts, including cultural presentations, represent 43% of total Biennium Grants awards and 72% of total Artists in the Schools projects.

There is concern with Section 5 which amends 103-8.5 HRS to allow the use of the Works of Art Special Fund for performing arts. Based on discussions with the Attorney General's Office on what is allowable and not permissible, the amendment of 103-8.5 HRS proposed in H.B.1378 to support performing arts would not be appropriate. While there is a great demand for the SFCA to support initiatives outside of the parameters of HR103-8.5 including performing arts, the fund does not allow for the broad use due to its source as bond revenue.

The State through the SFCA has an established funding pathway for Performing Arts through its Federally funded positions managing the grants programs. SFCA recommends the legislature establish an annual performing arts general fund appropriation 0f \$1,000,000 to the SFCA to be distributed to performing arts organizations and performing arts learning centers statewide through a process with criteria developed by the SFCA in consultation with the performing arts organizations.

With respect to managing Hawaii culture, education and community grants and programs, the SFCA requests the 4.5 FTE Federally funded positions be funded with \$384,426 in State general funds.

Chair Kapela and Members of the Committee:

The Department of the Attorney General provides the following comments.

The purpose of this bill is to establish the Performing Arts Grants Program to support performing arts within the State Foundation on Culture and the Arts (SFCA). The bill also expands SFCA's responsibilities to include the coordination, planning, promotion, marketing, and execution of performing arts events. Further, this bill allows the Works of Art Special Fund (WASF), established by section 103-8.5, Hawaii Revised Statutes (HRS), to be used for works of performing arts.

WASF is generally funded by tax-exempt general obligation bonds. To maintain the tax-exempt status of the general obligation bonds, WASF moneys must be used in a manner that is consistent with the requirements of the Internal Revenue Code. Under the Internal Revenue Code, tax-exempt general obligation bonds are used for capital projects (with certain exceptions). Using tax-exempt general obligation bond proceeds for operating purposes jeopardizes the tax-exempt status of the bonds. See Treasury Regulation sections 1.148-1(c)(4)(iii) and 1.148-10(a)(4).

To avoid this issue, we recommend deleting section 5 of the bill from page 5, line 15, through page 7, line 4, and adding a new section to chapter 9 to establish a new special fund to account specifically designated for the performing arts events as follows:

1. Amend the prefatory wording for section 2 on page 3, lines 1-3: as follows:

SECTION 2. Chapter 9, Hawaii Revised Statutes, is amended by adding [a] two new [section] sections to part II to be appropriately designated and to read as follows:

- 2. Add the following provisions after page 3, line 15:
- §9- Performing arts special fund. There is established in the state treasury the performing arts special fund, to be administered by the foundation.

 The revenues of the special fund shall consist of:
 - (1) Appropriations made by the legislature;
 - (2) Revenues or moneys derived from the foundation's operations;
 - (3) Grants, gifts, and donations received by the foundation; and
 - (4) All interest earned on moneys deposited in the fund.

The special fund shall be used for the coordination, planning, promotion, marketing, and execution of performing arts events.

3. Delete section 5 (page 5, line 15, through page 7, line 4), with subsequent sections renumbered accordingly.

We respectfully ask the Committee to consider our comments. Thank you for the opportunity to testify.

Chair Kapela, Vice Chair Kong, and members of the Committee. The Department of Business, Economic Development and Tourism (DBEDT) offers comments on HB1378, which seeks to establish a Performing Arts Grants Program as part of the Works of Art Special Fund and expands the State Foundation on Culture and the Arts' (SFCA) responsibilities to include support for performing arts events. This measure recognizes that performing arts are vital to Hawaii's rich cultural identity and deserve dedicated support alongside visual arts programs.

While DBEDT supports the bill's intent, after conferring with SFCA, we respectfully request an amendment in Section 5, which proposes to modify HRS 103-8.5 to allow the Works of Art Special Fund to include funding for performing arts initiatives. We understand that as this fund derives from bond revenue, its use must remain within the specific parameters as noted by the SOH Attorney General's Office.

Considering this issue, establishing a separate funding mechanism for a Performing Arts Grants Program in the agency would also achieve the intended goals of this measure. This approach would preserve the integrity of the Works of Art Special Fund while still achieving the bill's intent of providing a new funding mechanism for supporting Hawai'i's performing arts community.

I write in strong support of the establishment of the Performing Arts Grant Program in Hawai'i. - Direct economic activity from performances and festivals


- Indirect spending in surrounding businesses

I am the founder and Artistic Director of IONA Contemporary Dance Theatre (a dba of the 501c-3 Nova Arts Foundation.) Since 1990, IONA has been a leader in the Hawai'i dance community presenting over 1,000 performances ranging from theatrical productions, to site-specific pieces, to corporate events, in addition to classes and outreach to at-risk communities. IONA's mission is to effect a positive change in the community while providing opportunities for artists to evolve. Our dances connect audiences to such global concerns as the environment, multiculturalism, religious tolerance, equal rights, or domestic violence. Our belief that barriers such as poverty, criminal records, disability, and lack of access to the arts should not limit anyone's access to beauty and wonder.

I am writing in support of HB1378 / SB1577 and the SFCA's establishment of the Performing Arts Grants Program to support performing arts in the State. I am also in support of the use of moneys from the Works of Art Special Fund for performing arts.

This year, IONA is celebrating 35 years of outstanding artistry in our community, yet after a challenging pandemic and an even more challenging economy, we are struggling to keep our doors open. In fact, the dance community at large is finding it more difficult to create and perform live theatrical works due to the rising cost of rehearsal and performance space and technical expenses. Ticket income can no longer come even close to covering the expense of creating and staging contemporary dance in Hawai'i and taking a show to another island in order to build audiences is nearly inconceivable with today's cost of airfare and freight. Furthermore, Hawai'i's biggest live theatre audiences today have a mean age of 56 years, and there is much concern that future generations, used to getting their entertainment online, will all together abandon live theatre productions.

The SFCA's Performing Arts Grants Program will provide much needed assistance to a variety of Hawai'i performing artists to create and stage work that will continue to positively impact our community and bring people together. This program must be funded if we are to keep the diversity of our performing arts alive in our beautiful state! PLEASE SUPPORT THIS BILL!
