The Department of Business, Economic Development and Tourism (DBEDT) supports the intent of HB 1407, which seeks to foster entrepreneurship, support small business growth and promote technology commercialization within the state of Hawai'i.

DBEDT recognizes the intent of HB 1407 and appreciates the Legislature's focus on economic diversification and innovation. We would like to highlight that the state, through the Hawai'i Technology Development Corporation (HTDC), currently administers several programs that align with the goals outlined in this bill. These programs actively support the growth of Hawai'i's innovation economy and provide resources to entrepreneurs and small businesses across various industries.

Accelerator Small Business Technology (SBT) Program

HTDC's Accelerator SBT Program supports Hawaii-based accelerators that nurture early-stage technology and innovation startups. These accelerators provide mentorship, networking opportunities, and access to capital, enabling local entrepreneurs to scale their businesses and contribute to Hawai'i's economic growth.

Neighbor Island Innovation Initiative (NI3)

The NI3 program provides business and technical assistance to small businesses on Hawaii's neighbor islands, focusing on technology adoption and operational improvements. This initiative aligns with HB 1407's goals of promoting equitable economic development across the state.

NOTE: The last year the **Hawai'i Technology Development Corporation (HTDC)** supported the **Neighbor Island Innovation Initiative (NI3)** program was 2018. The NI3 program was closed due to federal funding constraints (USDA Rural Development Grant).

- 86 companies mentored on Kaua'i and Hawai'i Island
- 29 new HTDC clients

Hawai'i Center for Advanced Transportation Technologies (HCATT)

HCATT facilitates the development of advanced transportation technologies, including hydrogen and renewable energy systems. This program contributes to sustainability and technology commercialization, supporting HB 1407's objectives of fostering innovation in clean energy and transportation sectors.

- The Pacific Energy Assurance Renewables Laboratory (PEARL) microgrid, an energy demonstration project with the Hawai'i Air National Guard is 100% federally funded. To date, the project has expended \$14.1M in the state in development and construction of the microgrid.

Dual-Use Technology Development Accelerator (DUTDA) Program

HTDC's DUTDA Program supports companies developing technologies with both commercial and military applications. By helping businesses access federal funding and fostering partnerships with the Department of Defense, this program promotes innovation and aligns with HB 1407's focus on leveraging federal partnerships for economic growth.

- Innovate Hawai'i has leveraged funding from the National Institute of Standards and Technology Manufacturing Extension Partnership (NIST MEP) program to increase our collaboration with local Hawai'i machine shops to promote

advanced manufacturing technology workforce training that will support defense readiness for the state of Hawai'i.

Recommendation:

DBEDT appreciates the intent of HB 1407 and acknowledges the importance of fostering a robust innovation ecosystem in Hawai'i. We respectfully recommend that the bill be amended to increase resources and funding to these existing HTDC programs to further accomplish the bill's objectives. By enhancing the capacity of these programs, we can amplify their impact and ensure broader support for Hawai'i's entrepreneurs, small businesses and technology innovators.

DBEDT submits these comments, supporting the intent, in recognition of the effective programs already in place that align with HB 1407's goals. We look forward to continuing to collaborate with the Legislature to strengthen Hawai'i's innovation economy and support the growth of our local businesses.

My name is Sherry Menor, President and CEO of the Chamber of Commerce Hawaii ("The Chamber"). The Chamber supports House Bill 1407 (HB1407), which requires the Department of Business, Economic Development, and Tourism to establish a Chamber of Commerce Grant Program.

HB1407 aligns with our 2030 Blueprint for Hawaii: An Economic Action Plan, specifically under the policy pillar for Business Services. This bill promotes policies that drive economic growth, enhance workforce opportunities, and improve the quality of life for Hawaii's residents.

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports HB 1407, which requires the Department of Business, Economic Development, and Tourism to establish a Chamber of Commerce Grant Program. This program can provide much-needed resources to strengthen Hawai'i's business community, including agricultural enterprises and value-added food producers.

The Chamber of Commerce of Hawai'i, Island Chambers, and other Chambers support agricultural businesses across the state. These organizations provide critical services such as business development support, networking opportunities, and advocacy for policies that strengthen local industries. For agriculture, chambers of commerce play an essential role in helping farmers, ranchers, and value-added food producers navigate regulatory processes, expand market access, and secure financial resources to grow their businesses.

Entrepreneurs are essential to the future of Hawai'i's agricultural sector. businesses with the resources needed to expand, create jobs, and strengthen local economies. We are eager to continue expanding this program.

H.B. 1407 aligns with our mission to empower entrepreneurs by providing access to capital, mentorship, and technical support. By ensuring chambers of commerce have the resources to develop mentorship programs, skill-building workshops, and business incubation initiatives, this bill will create more opportunities for Hawaii's small businesses to succeed.
